Re: Site Plan Review for 444 Indian Church Road, West Seneca, NY

Honorable Planning Board Members:

Before you is a request for site plan approval for a single story, wood frame, slab on grade, office building located on the northwest corner of 444 Indian Church Road. The office building is approximately 1046 sq. ft. and will be used as an office for the owner's collection agency business. His current business is located at the Southgate Plaza and due to increased rent and lease agreements, it has been deemed more feasible to relocate and erect a small building on the Indian Church Road property.

Location and Zoning: The new office building will be located adjacent to Great Lakes Pizza Co., on the same lot (C-2). It is surrounded on the north by railroad tracks (C-2), west by a residential home and then the main line Thruway (C-2), east by Harlem Road (M-2) and south by the Harlem Road ramp (M-2).

Business: A collection agency will be located in the new building. There will be 5 employees and service with no outside customers.

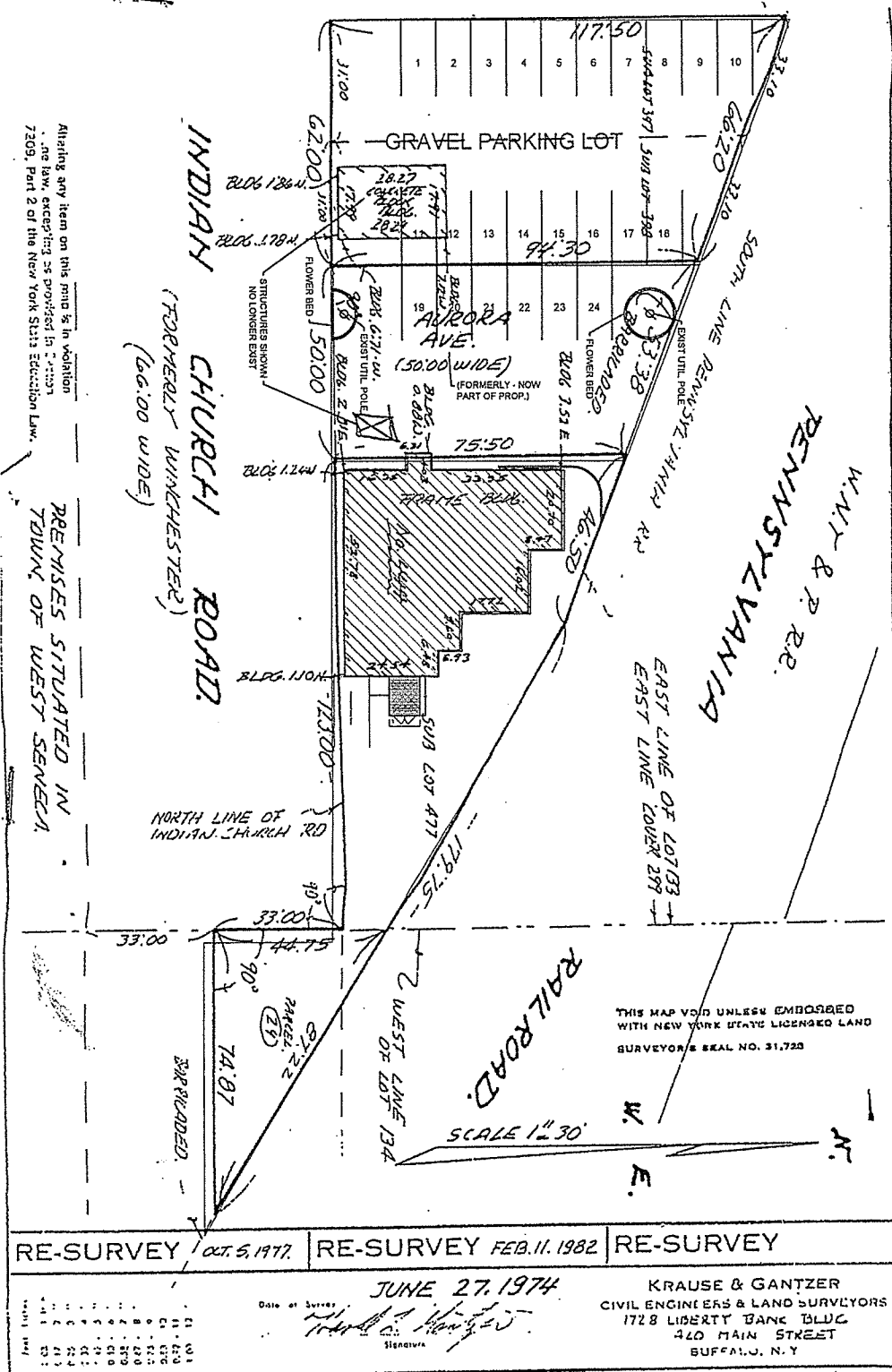
Parking: The parking lot will be shared by both businesses since the time of operation will be opposite to each other. Operation of the collection agency will be between 8a and 5p while the pizza parlor will be open from 12p until 11p. The only overlapping parking would occur during lunch, which is the slowest time of the day for the pizza parlor. Also, the entry for the pizza parlor is on the west side of the building.

Trees: There are currently no trees located on the property.

Altering any item on this plan is in violation of the law, excepting as provided in Section 7209, Part 2 of the New York State Education Law.



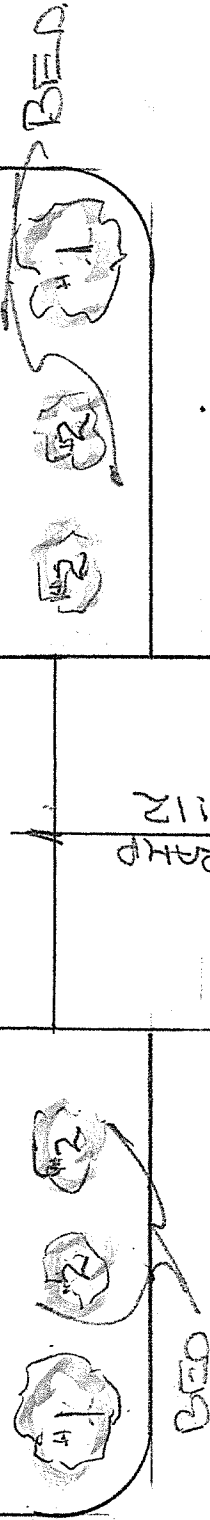
