1. Box out and pave area in northeast corner of front parking lot.....\$4,935.00
2. Credit for not installing the island in the rear..... \$2,050.00
  - A. Which has been short paid on pay application 1
3. Asphalt Sealing.....\$6,558.50
  - A. Sealing of asphalt area clouded in red, including driveway, entire existing front parking lot and new front parking lot. Install additional coats over newly striped handicapped as necessary.
  - B. Total Area - 50,450 sf @ \$0.13/sf = \$6,558.50
4. Striping.....\$1,495.00
  - A. Re-stripe as shown (existing front parking lot and new front parking lot, 2 coats of paint for all striping).
  - B. Install 15 new handicapped markings (meets ADA, square markings, 2 coats of paint, 'VAN' marking on 2 spaces)

The above work can be completed for a lump sum of **\$12,988.50**

- All work to be completed with Erie County Prevailing Wages
- All work completed 2014 construction season
