Project Description

The Town of West Seneca seeks to strengthen its capacity to manage its Buffalo River tributary corridors, and to implement a habitat restoration plan for the oxbow wetland on Buffalo Creek.

Project Abstract

The 30-acre oxbow wetland-floodplain complex on the Buffalo Creek is about 10 miles upstream from the river's mouth at Lake Erie. Because this area is one of the last remaining undeveloped parcels in the Town, it is under extreme development pressure. Now it is time to transfer and build stewardship capacity within the Town of West Seneca and its Environmental Commission. Aid from this grant will allow for the reduction of the priority invasive plant species to less than 1 % of the Town-owned portion of the wetland. Pollution is a factor. To increase native plant communities to 70% of the site, we will continue planting and propagation of native trees, shrubs, forbs and grasses with well-coordinated volunteer efforts. Additional goals will be to enhance habitat in order to ensure protection of at least two resident species in conservation need: Snapping turtle and Redheaded woodpecker. We will also increase suitable wildlife habitat within a half mile radius of the Town-owned parcel by at least 10% by acquiring or otherwise protecting adjacent parcels in the riparian corridor. We will develop programs for protection of other riparian floodplains in the Town portion of the Buffalo River Watershed and create a structure for on-going monitoring and maintenance of same. We will develop a pool of trained volunteers for on-going site work. Zoning and land-use ordinances will be reviewed and recommendations for change will be made to further ensure protection of natural resources
