NON-EXCLUSIVE FACILITIES USAGE PERMIT & LICENSE AGREEMENT TOWN OF MEST SEHECA RECREATION DEPARTMENT

This Non-Exclusive Facilities Usage Parnit & License Agreement (the "Agreement") is by and between the "Town of West Seneca, located at 1250 Union Road, West Seneca, New York (the "Town"), and Courtney McDermony USA Track & Field Licensee Nume & Instruct Corporation Name written out in full), located at 132 East Washington Serect Suite 800 Indianapolis, IN 46204 (the "Licensee") (collectively, the "Parties"), and is effective the date it was executed on behalf of the Town (the "Effective Date").

Recitals

WHERSAS, the "own owns and openets certain recreation facilities, including but not limited to: baseball diamonds, surfault deutonds, somer ficities and an ice riple; and

WHEREAS, the Licenser descress to the effection owned and operated recreation facility for the purpose of conducting granes, practices or any other purmitted use as set forth in this Agreement; and

WHEREAS, the Town is willing to account the Licensee, and its employees, volunteers, agents, representatives and invitees to use the Facilities upon the terms, and subject to the conditions set forth in this Agreement.

NOW. THEREFORE, the Parties agree as follows:

- 1. Subject to the exactions, obligations and terms of this Agreement, including the Facilities Usage Rules and Regulations, set form and affected hereto as EXHIBIT A, the Town grants the Licensee and the License's Permanel Users a non-evalusive license (the "<u>License</u>") to use the facilities set forth and described within the hereto attacked EAHBIT B (nin "<u>Facilities</u>"). By executing this Agreement, Licensee asknowledges and affirms it has reviewed and understands it shall by obligated to follow the Facilities Usage Rules and Regulations. Such use shall be solely for the Permitted Use as set forth below.

Other Licensee obligations

Licensee must meet with, provided any requested information in regards to the event and obtain approval for the event from West Seneca Pelice Chief Dan Denz and West Seneca Highway Superintendent Matthew D. English. This is the Libensee reasonability to confact and set up meeting date(s) and time(s).

Licensee must attach to this agreement a copy of the event map and any other event information.

- Other Town obligations:
- 8. Failure of the Bettes to agree upon any changes to, or extension of, the Permitted Use Dates will result in expiration of the Farm: Productions, the Town will have no liability for damages of any kind whatswever to the Licensee.  to cooperate with the Town's personnel at all times.
- 11. Neither the Licensee nor its invitees will make any alterations, improvements or changes of any kind to any of the Facilities or other Town property. If any alterations take place, the Licensee will immediately neutry the Town in witing of such prohibited alterations. If any damage is sustained by the Facilities during the Licensee's use, then the Facensee shall pay the Town for such damages.
- 12. The Licensee agrees to indemend, and lability, damages, expenses, causes of action, suits, judgments and claims of any nature arising out of or in any manner connected with injury to presens or property which results from the Town's use and access of the Facilities, only to the extent that such dablety, damages, expenses, causes of action, suits, judgments and

The Licensee will maintain, or cause to be maintained, in full force and effect, at the Licensee's expense, one or more policies of general comprehensive liability insurance (the "Licensee's Liability Insurance; with combined single limit coverage of at least one million dollars (\$3,000,000,000) per occurrence, and at least three million dollars (\$3,000,000,000) in the aggregate, naming the Town as an additional usuarce.
