Pursuant to the Plan, Croglio agrees to plant the trees in the Town right-of-way, or elsewhere in the subdivision depending on the lot size and configuration. 112 trees are planned to be planted, and the Trees are on the Town of West Seneca approved tree species list. Some discussion ensued. A concern was raised that the trees will be planted in a manner that would prevent them from becoming root bound over time. There is an expectation that the developer will use <u>best management practices</u> in the planting of the trees to ensure survival.
