# **CONCRETE STORM DAMAGE REPAIR**

Chief Denz responded that BOCES holds educational programs at the school so the speed limit will not be increased.

# **CARBON MONOXIDE LAW FOR COMMERCIAL BUILDINGS**

Senior Code Enforcement Officer John Gullo stated a new law mandates carbon monoxide detectors in commercial buildings and everyone should be compliant by June 2016.

#### **CODE RED SYSTEM**

Councilman Hart stated the town used Code Red to advertise the opening of the resource center and there was some criticism he felt was unjustified. He questioned Senior Code Enforcement Officer John Gullo if the town has a flat rate contract for the Code Red system. Mr. Gullo responded the town has unlimited use of the Code Red system and it will be used for emergency messages and general messages.

# PUBLIC HEARING FOR AMENDMENTS TO TOWN CODES

Town Attorney John Fenz requested a public hearing be scheduled for November 9<sup>th</sup> to discuss revisions to the Town Code including street lighting requirements for developers, administrative fees for the building department, food truck regulations, electrician licensing, defining LED temporary signs and the municipality's role in regulating exotic animals. Councilman Hanley asked that solar panel regulations be added to the list of proposed revisions.

## **IMPROVEMENT PROJECTS**

Town Engineer Steven Tanner stated that years and years of doing nothing has lead to numerous infrastructure improvement projects that are required and they are moving deliberately to make sure money is spent in the right places. Mr. Tanner further stated Town Hall restrooms should be complete in two weeks and tomorrow the Kiwanis building will have air monitoring for pre-demolition that will be used for comparison when abatement work occurs within the next few weeks.

# PRESENTATION OF COMMUNICATIONS BY BOARD MEMBERS AND DEPARTMENT HEADS

#### **BURCHFIELD RESTROOMS**

Councilman Hart questioned issues with the Burchfield restrooms. Town Engineer Steven Tanner responded most of the issues have been fixed and the remainder of the restoration work will be done in the spring by the Buildings and Grounds Department.

#### **FLOHR AVENUE FLOOD ABATEMENT**

Councilman Hart questioned the flood abatement project on Flohr Avenue. Town Engineer Steven Tanner responded the NYSDOT had a problem with the Harlem Road project and work took longer which caused some issues with Flohr Avenue residents. In about two weeks a plan will be submitted to the DEC for the outfall at the Cambridge Avenue dam which he believes will help reduce the issues on Flohr Avenue.

#### **CAZENOVIA CREEK ICE CONTROL STRUCTURE**

Town Engineer Steven Tanner stated the Army Corps of Engineers will be doing a project to take care of some of the deficiencies at the ice control structure and the town is mandated to fund part of that project. The cost to the town will be \$250,000 and funds are being budgeted next year. In the meantime, Highway Department crews continue to do a great job removing trees from the structure and also maintaining access to the sewers in that area.

#### **SENIOR SERVICES UPDATES**

Senior Recreation Therapist of Senior Services Mary Josefiak stated they recently celebrated national "Do Something Nice Day" at the senior center and received donations of over 500 pounds of canned goods and paper products that will be distributed to area pantries and people in need. A health insurance fair will be held at the senior center on Wednesday, October 21<sup>st</sup>.

#### STREET LIGHT ISSUE

Town Attorney John Fenz stated he contacted the Public Service Commission on the street light issue and their recommendation is that the town write down every light pole location and light that is out. He and Councilman Hanley are working on a better way for residents to reach out to the town and issue the complaints directly to the Public Service Commission so utility companies are held accountable.

#### **RESOURCE CENTER**

Councilman Hart invited residents to take advantage of the new resource center that is now in operation at New Hope Church.

# AMENDMENT NO. 1 TO MEMORANDUM OF UNDERSTANDING

This Agreement dated the 15<sup>th</sup> day of October, 2015, by and between the Town of West Seneca, a Municipal Corporation, located at 1250 Union Road, West Seneca, New York, (the "Town"), and the West Seneca Central School District, with offices located at 1397 Orchard Park Road, West Seneca, New York (the "District") (collectively the "Parties).

#### WITNESSETH:

WHEREAS, the Town and the District entered into an agreement (the "<u>Agreement</u>") whereby the Town's Police Department would provide School Resources Officers to the District in exchange for reimbursement payments set forth in a schedule contained therein; and

WHEREAS, at the time the Parties entered into the Agreement it was anticipated that the District would receive certain grant funds to advance these payments; however, due to grant requirements the Town received \$25,000.00 in grant funding for the DCJS School Resource Officer Grant; and

WHEREAS, the Parties mutually agree to modify the Agreement in the interest of preserving its original intent and ensuring that Town and District taxpayers realize the benefit of the grants funds and

NOW, THEREFORE, in consideration of the mutually benefit to the Parties by modifying the Agreement it is hereby agreed that:

- 1.) The grant funds received by the Town shall be applied to the District's monthly reimbursement payments for the months of October and November of 2015.
- 2.) Once the grant funds are exhausted, the District shall pay the Town for the remaining balance of any monthly reimbursement payments as they become due.

In recognition to the service of our veterans, the Town Board of West Seneca would ask that you rename Union Road to Veterans Memorial Highway. The commitment of our nation's veterans to this country is a blessing to us all. To be willing to go anywhere around the world to defend people whom they've never met is one of the most selfless acts any man or woman can be a part of.

Residents of Erie County, and the Town of West Seneca, have continued to serve this country during times of war and aren't immune to the sacrifices it takes to preserve our freedoms. Go through any city, town, or village in Erie County and I'm sure you'll encounter many residents that served this country because they believe strongly in standing up for those who are oppressed and live in peril.

The Town of West Seneca has looked to recognize the service of our nation's veterans. A few years ago we renamed the park at town hall to Veterans Memorial Park and constructed the Walkway of Freedom to honor our servicemembers — while also acknowledging the wars they have been in. The greatest part about the Walkway of Freedom is being able to look down at the bricks on the walkway and see the names of residents who've served in the military. It's a truly humbling experience to see how many people have devoted themselves to upholding our country's principles.

West Seneca also takes part in WNY Kids Are Heroes Too program which helps to waive recreation fees for children of veterans. Furthermore, the Harvey D. Morin VFW Post just recently named two of their halls after two men who were killed in Iraq.

Their unwavering commitment shouldn't be forgotten – and let us ensure that we do our part in remembering all they've done for us by naming Union Road in West Seneca after them.
