CODE ENFORCEMENT OFFICER JOHN GULLO

- Agenda item to revise the fee schedule Requests to reschedule meetings with the Planning, Zoning and/or Town Board will result in additional charges to cover cost of publication, correspondence and postage. Councilman Hanley questioned the cost for people who do not get a building permit and Mr. Gullo responded the fee is doubled.
- ▶ Proposed changes to Town Code will allow violation letters to be sent first class vs. certified mail; technical specifications on fire exit signs; changes to some accessory uses relative to pools and electronic signs. Councilman Hart requested a local law be drafted for expert fees. Attorney for the Town Charles Grieco stated he will put together the information and schedule a public hearing for the October board meeting.
- ➤ Code Red update sign up forms are available. Presentations will be taking place at adult living facilities and the senior center. Home phones are automatically connected to the system. Residents have the option of adding cell phone numbers, email addresses and the type of notifications they want to receive.
