PRESENTATION

1. Supervisor Dickson re Presentation on Historical Preservation Draft law

Town Historian James Pace provided the following updates on establishing a Historic Preservation Code:

- ✓ Fifty buildings standing and in use that were built by the Ebenezer Society
- ✓ Proposal is based on the NYS Office of Historic Preservation recommends
- ✓ The purpose is stated in the draft and would provide for the creation of a historic preservation commission for the purpose of making recommendations to the Town Board
- ✓ West Seneca could then apply for Certified Local Government status which would make the town eligible for funding to maintain, preserve, and restore the appearance of structures
- ✓ A public hearing will be scheduled for July 18, 2022

Mr. Yots provided the following information:

- ✓ Assists property owners in preserving properties through historic preservation tax credits both commercial and residential
- ✓ The commission will aid property owners in decision making
- ✓ Local government grants available

Councilmember Piekarec stated he believes the law was well written and pointed out the discrepancy in term lengths on pages 2 and 4. Councilmember Piekarec would like all five members to be approved by the Town Board with staggered terms similar to the Planning and Zoning Boards with an attendance policy.

NEW BUSINESS

11-A ANNOUNCEMENTS & DISCUSSIONS

1. Town Attorney re Proposed Acceptable Use Policy for electronic equipment

Supervisor Dickson stated Mr. Trapp has submitted the policy for best practices for consideration by the Town Board members and no formal action is required at this time.

2. Recreation Supervisor re Discussion of the pool status and Summer Aquatics appointments

Recreation Supervisor Lauren Masset stated that she has received a limited number of applications for lifeguards which would impact the pool hours.

Councilmember Breidenstein stated staffing needs have been reviewed and resident participation relative to the costs of opening and operating the pool:

- \$47,280 annually plus electricity
- Personnel \$1,100 per day
- Upcoming costs of \$150,000 for resurface and \$250,000 \$270,000 to replace the gutter system.

Councilmember Piekarec questioned the number of applicants compared to last year. Ms. Masset stated there were 23 aquatic staff in 2021 and to date there are 18; 1 supervisory staff last year and 3 this year; the pool was open 4 days per week.

Supervisor Dickson questioned what alternatives people would have. Councilmember Breidenstein stated the school district is offering summer swim programs. Supervisor Dickson stated the YMCA has a pool. Councilmember Breidenstein stated LA Fitness and Eggert Road YMCA location have pools, and there is a swim club in Orchard Park.

Councilmember Piekarec questioned the time frame for the pool maintenance. Councilmember Breidenstein stated Buildings and Grounds indicated approximately 18-36 months for maintenance. Councilmember Piekarec stated the pool could be opened this summer as it is in the budget and then alternative options for the site could be examined or the necessary improvements could be spaced out over two years. Councilmember Breidenstein stated the pool would need to be made ADA compliant if any improvements are undertaken.

Councilmember Piekarec stated he is in favor of opening the pool this year and looking at alternative uses for the site.

Supervisor Dickson questioned Ms. Masset if she is aware of the school district's readiness to open their pools to the residents. Ms. Masset stated she spoke with the Continuing Education office as they are offering swim lessons and an adult exercise class; she is not aware of open swimming opportunities. Supervisor Dickson questioned the relative costs for the alternative sites. Ms. Masset stated she is not aware. Councilmember Breidenstein stated a YMCA membership is approximately \$72 per month.

Councilmember Cantafio questioned Ms. Masset for alternative uses for the pool's site. Ms. Masset stated she would like resident feedback, but a few ideas would be extending the splashpad or multisport courts with outdoor skating in the winter. Councilmember Breidenstein stated some ideas he has heard include beach volleyball, pickleball, a small dog park, and an outdoor ice rink.

Highway Superintendent Brian Adams stated they are currently cleaning the pool and patching the walls, and expect to fill this week. Mr. Adams agreed there are large upcoming expenses. At this point they will have the pool ready to open without any pump issues.

Councilmember Breidenstein stated he reluctantly recommends closing the pool and noted there are currently 5 fewer lifeguards than last year.

Supervisor Dickson stated his concern is for the residents that do not have any alternatives.

Councilmember Kims expressed concerns with keeping the pool open for 100 residents, not knowing total cost and is in favor of closing the pool.

Councilmember Piekarec stated he agrees with exploring alternatives but would like to open the pool this year as it was budgeted for, and the opening process has started.

Councilmember Cantafio stated he is also extremely reluctant to recommend closing the pool but the reality of low staffing, possibility of mechanical issues, and limited hours of operation must be seriously considered.

Highway Superintendent Adams reminded all the costs of changing over the site and noted the budgeted funds could be reallocated.

Councilmember Cantafio questioned the usage of the splash pad. Ms. Masset stated she cannot provide new numbers, but it is always very busy. Councilmember Cantafio agreed he has received positive feedback and meeting the residents needs as they currently stand can be done.

Supervisor Dickson stated he knows there will be disappointed seniors that utilize the pool.

Motion by Councilmember Breidenstein, seconded by Councilmember Cantafio, to close the pool at Veterans Park for community use.

2. Town Attorney re Local Law No. 8 – Revision to Chapter 28, Planning Board and Zoning Board of Appeals

Motion by Supervisor Dickson, seconded by Councilmember Kims, to schedule a public hearing on June 20, 2022, at 6 P.M. for the purposes of amending Section 28-2 of the Code of the Town of West Seneca with respect to the elimination of the reference to the Zoning Commission which is already codified under Chapter 120 and to further provide for minimum attendance requirements for Planning Board members.

Town Attorney Chris Trapp stated one aspect being addressed is "members of the Planning Board are members of the Zoning Commission" and noted the town does not have a Zoning Commission, instead there is a Zoning Board of Appeals and members cannot belong to both. The second aspect deals with absenteeism and provides that after three consecutive absences or in the event that a member misses over thirty percent of the in-person meetings in one calendar year, that individual be removed from the Planning Board after notice and a public hearing.

Councilmember Cantafio questioned Mr. Trapp on the wording "may be removed" and "be removed" and if this contradicts the attendance policy that was recently adopted by the Town Board. Mr. Trapp stated the actual revision does state may be removed.

ISSUES OF THE PUBLIC

A resident referred to the insurance policy and asked the following questions:

- ✓ What is the status of the insurance representative's efforts to negotiate additional savings insurance premium Supervisor Dickson stated the insurance representative did try but was unsuccessful.
- ✓ Is the town aware of how many municipalities the three brokers interviewed represents Supervisor Dickson stated the question was asked but does not recall the exact numbers for each.
- ✓ How much of the increase was budgeted for Supervisor Dickson stated he budgeted for a thirty percent increase; it was a 37% increase; the town received a letter of notification of a 25 30% increase. Director of Finance Alissa Straus stated the letter was received before the 2022 budget was prepared and well before the fire. Councilmember Breidenstein stated the market has shifted. Supervisor Dickson elaborated and explained the companies previously made money from investing the premiums, not merely the premiums themselves and that has changed due to the stock market.

Residents referred to the town pool and made the following questions/comments:

- ✓ Have residents who use the pool been asked what alternatives are realistic for them Councilmember Breidenstein stated he has been told by people they prefer the splash pad as it is always open.
- ✓ Providing safe and enjoyable outlets should be a priority, they are considered by potential residents Councilmember Cantafio stated his vote was based on a realization that the town cannot staff the pool to make it worthwhile and the plan is to transition to activities that will meet community needs. Councilmember Breidenstein stated the data indicated the pool is not in demand based on usage. Supervisor Dickson reiterated the intention of serving the community's needs.
- ✓ How many residents use the Senior Center in relation to the resources and cost put into it Supervisor Dickson stated it is packed every time he is there. Councilmember Piekarec stated he believes the membership is 935.
- ✓ Why can other towns operate a pool Supervisor Dickson stated that is not necessarily true, Orchard Park has a lake, and some pools are not being opened this year.
- ✓ What hours will the restrooms be open at the pool and splash pad Highway Superintendent Brian Adams stated restrooms are open daily from 7:00 A.M. 7:30 A.M. and closed between 8:00 P.M.— 9:00 P.M. and this is the same for the restroom in Veterans Park. Supervisor Dickson stated there is remaining grant money for a comfort station closer to the baseball diamond.
