 - TS would like W. Seneca to participate in Erie County's Community Climate Action Planning (CCAP) program, and will contact Town Board re this initiative.
 - TS would like W. Seneca to participate in the Climate Smart Communities program, which would necessitate the hiring of a coordinator to facilitate the program – (money for salary is available via grant funding) – she will contact Town Board re: this initiative
 - RR will provide replacement (as necessary) of storm drain medallions along Town streets, intends to request assistance to ID locations of missing medallions from B. Adams (Town Highway Supervisor) this Spring.

III. WSEC PROJECTS - UPDATES/DISCUSSION

- 1. Oxbow (2805 Clinton St.) on 2/21, RR observed damage to 3 trees at site
- 2. Standing Subcommittee reports:

Tree Issues Subcommittee – as per MW, Young Development intends to plant the agreed upon trees this spring contrary to our advice. The proposed tree planting layout per site, completed this fall has been eliminated but all information concerning the tree type and layout has been forwarded to Town Code Enforcement officer.

Education Subcommittee:

- Environmental Corner TS has posted information re: W. Sen. Deer Task Force, and also the link to the Town's survey - Also, posted: <u>Minimize Deer Foraging</u>
- Creek Awareness and Safety EH would like expand the relevant information into other environmental activities (i.e. Earth day/creek cleanups, National Night Out)
- TS will post information, photos re: the Meyer Rd. wetlands viewing platform on Facebook, will solicit interested parties to participate in WSEC activities.
- Town Recycling Program discussion re: sharing information about recycling best practices – (TS and CG will collaborate)
- Other RR completed Deer Foraging topic (see above), is working on downspout disconnect topic
- Water Quality Issues Subcommittee:
 - Buffalo Creek Canoe/Kayak Launch 880 Harlem Rd. RR will contact NYSDEC re: possible site improvement
 - o Residential Rain Barrels RR will initiate in Spring 2022
 - Municipal Rain Barrels RR will initiate in Spring 2022
 - Storm Drain Marking (see above).
- 3. New WSEC Grant opportunities CG provided a handout describing programs: available:
 - Recreational Trails Program
 - Environmental Protection Fund Grants Program for Parks, Preservation, and Heritage Parks Program
 - Local Waterfront Revitalization Program
 - Climate Smart Communities Grant Program
