8. Town Attorney re East & West Road Rehabilitation

RESOLVED, the Town of West Seneca Town Board certifies that as part of the Project it will perform sanitary sewer rehabilitation work to approximately 750 feet of sanitary sewer along East & West Road immediately west of Union Road in an amount not to exceed \$500,000.

SOUTHGATE PLAZA ASSESSMENT CHALLENGE

Supervisor Meegan referred to an assessment challenge filed by Southgate Plaza and stated the town lost the case and then filed an appeal. The decision was recently unanimously overturned in favor of the town.

Town Attorney John Fenz commented on the importance of going forward with the appeal, noting Southgate Plaza added approximately \$2 million in fair market value, and if the case had been decided against the town the tax burden would have gone to other taxpayers. The system of changing valuations on properties was validated and it proved the town is acting in a consistent matter.

ISSUES OF THE PUBLIC

- A West Bihrwood Drive resident questioned the annual benefit as a result of winning the Southgate Plaza assessment appeal. Town Attorney John Fenz stated the annual amount is \$41,000.
- A West Bihrwood Drive resident questioned how the town identified sidewalks in need of repair and commented on the lack of sidewalks in some areas. Code Enforcement Officer Jeffrey Schieber stated code enforcement officers walked the streets in Phase II and looked for raised or sunken sidewalks that could be tripping hazards. Supervisor Meegan stated the work is being done in zones and any concerns can be directed to the Code Enforcement Office. She further stated in the past residents could chose whether or not to install sidewalks and the town cannot go back now and make the property owner add sidewalks.
- A Covington Drive resident questioned the status of the Burchfield Center. Town Attorney John Fenz stated a formal summons and complaint has been filed and the case is currently in litigation with all parties being served.
- A Covington Drive resident commented on the Leydecker Road Bridge and Mill Road Bridge that are in bad shape. Supervisor Meegan stated the town does not own the bridges and if there are plans by the county or state for any repairs there would be a public hearing on the matter.
- A Covington Drive resident questioned the status of the sewer project work under the consent order. Town Engineer Steven Tanner responded it is a 10 phase project with phases 1 − 4 being complete. Phase 5 will continue next year and the town is seeking additional grant money. As they complete phases, the sewers are in better condition and the engineers will reevaluate phases 6 − 10. The system is running much better with a big decrease in basement backups. Mr. Tanner stated the town would like to see the siphon fixed so the temporary pumps at the high school can be removed.
- James Manley of the West Seneca Veterans Committee reported the following:
 - ✓ All 1900 engraved bricks are back in the Walkway of Freedom and he is looking forward to installation of signs and learning stations along with benches outside the reflection pond.
 - ✓ Bricks for the Walkway of Freedom will go on sale October 2018 through February 2019. The cost will be \$90 per brick and order forms will be available in the Town Clerk's Office, West Seneca Library, American Legion Post 735 and online at wsvets.org.
 - ✓ The cost of the Korean War Monument is \$15,500 and \$8194 has been collected through fundraising. Residents that would like to help with the monument can contact Mr. Manley or go online to wsvets.org for more information.
 - ✓ Tuesday, August 7th is National Purple Heart Day and a ceremony honoring recipients will be held on August 7th at 1:00 P.M. at the Old County Hall Court Room.

PRESENTATION OF COMMUNICATIONS BY BOARD MEMBERS AND DEPARTMENT HEADS

MOODY'S REPORT UPDATE

Director of Finance Megan Wnek stated in July 2017 Moody's placed the town on a negative outlook and it was the planned use of fund balance that led to the downgrade. The 2017 budget included the appropriated use of \$900,000 of fund balance in the General Fund and an additional \$350,000 of fund balance in the Highway Fund. Of the \$900,000 in the General Fund, \$837,000 was used and in the Highway Fund the town went over the appropriated fund balance by \$175,000. In the 2018 budget, the amount of appropriated fund balance in the General Fund was reduced to \$450,000 and the appropriation of fund balance in the Highway Fund was completely removed. The town also has anticipated savings in 2018 with regard to personnel costs, anticipated state aide coming in and a planned build up of reserves of \$220,000 in the Highway Fund. As a result of these factors, Moody's removed the negative outlook and see the town stabilized in 2018. The goal is for Moody's to see the turnaround in 2019. Mrs. Wnek further noted bonds were sold this month at a rate of 3.25 percent which is better than previous years.

Councilman Hart commented that flooding in the Lexington Green area cost approximately \$2 million and the November storm cost \$1.5 million. Both were significant unplanned hits to the fund balance.

Mrs. Whek stated per the town's fund balance policy, the town will maintain adequate fund balance to provide flexibility and to mitigate current and future risks, to ensure stable tax rates, to provide for one-time opportunities and to retain favorable credit ratings. The town has endeavored to maintain an unrestricted fund balance of two months of regular operating expenditures. As of December 31, 2017 the unassigned fund balance in the General Fund is approximately 16.6 percent of total General Fund operating expenditures, which is directly in line with the policy.
