- An Indian Church Road resident questioned/commented on the following:
 - ✓ Encouraged residents to vote yes on the upsizing proposition
 - ✓ Number of electrical re-inspections performed and suggested the town request copies of electrical code violation letters sent to residents Code Enforcement Officer Jeffrey Schieber explained the process of electrical inspections and requested a list of the addresses in question.
 - ✓ Sale of soccer complex Supervisor Meegan responded the soccer complex is not being sold.
 - ✓ Who is responsible for electrical work at Spot Coffee and the furnishings Supervisor Meegan responded the electrical work is being funded by Spot Coffee and the town is providing the furnishings.
 - \checkmark Second floor of the Community Center Councilman Hanley stated the second floor is used for storage.
- A Singer Drive resident questioned/commented on the following:
 - ✓ Street lights on Ridge Road have not been converted Councilman Hanley stated a status report was received from the contractor and the lights on Ridge Road and Orchard Park Road have yet to be changed.
 - ✓ Who is the electrical contractor for Spot Coffee and will they be required to file permits
 with the town Code Enforcement Officer Jeffrey Schieber stated the electrician has
 not been chosen and they will file electrical permits along with associated fees.
- A Mill Road resident questioned if there are any new businesses coming into the town. Councilman Hanley responded some of the current proposals include real estate development, a car wash and a truck center in the industrial park. Councilman Hart stated the Chamber of Commerce is always working to bring in new business.

ISSUES OF THE PUBLIC

- A Covington Drive resident questioned/commented on the following:
 - ✓ Agenda for work sessions Supervisor Meegan responded there is no agenda for work sessions.
 - ✓ Was the part-time public safety dispatcher advertised and is it a new position Chief Denz replied the position is not a new position and it was advertised through the fire districts due to the qualifications required for the position.
 - ✓ Appointment of a full-time sanitation laborer Supervisor Meegan stated Mr. Locher worked as a part-time sanitation laborer for three years.
 - ✓ Appointment of a part-time van driver Supervisor Meegan stated the position was advertised and applications are always being accepted. The new hire replaces an employee who passed away.
 - ✓ Addition of another town park Supervisor Meegan replied an area of the state school was being looked at for a dog park.
- A Union Road resident questioned how seniority is determined. Highway Sup't. Matthew English stated the seniority date is based on when the employee becomes full-time.
- A Pine Court North resident submitted information on term limits used in Amherst and suggested following their law.
- An Arrowhead Drive resident questioned/commented on the following:
 - ✓ The proposed tax increase Councilman Hanley stated the amount is 3.95 percent, but this is not a final figure.
 - ✓ When employee contracts expire and would like to see negotiations made public -Supervisor Meegan stated the three contracts (police, blue collar and white collar) are negotiated by the Town Board and labor counsel and expire in 2021, 2022 and 2023. Town Attorney John Fenz stated under the Taylor Law the established rules state the collective bargaining process is confidential to both parties.
