- Report on the Ebenezer Brook Restoration Project The town is receiving a \$20,000 grant; the town will also contibute \$5000 and two property owners will be contributing a total of \$10,000 which will bring the total project cost to \$35,000
 - ✓ First phase of the project will work on the creek from Seneca Street to the town line.
 - ✓ Second phase will run from the high school property to the residential areas by Jasimine and Iris Avenue
 - √ 1250 feet of degraded section of the brook will be cleaned up; bank stabilization and planting of native species along with drainage issues will be addressed
 - ✓ Educational outreach will be provided to residents on ways to curtail the problem
- Project at Burchfield Nature & Art Center Identification of invasive species will be performed; invasive species will be removed and replaced with native species plantings
