J Randy Steiner stated his proposal to open an AAMCO Transmission shop in the vacant building at 1412 Ridge Road. The site has been an eyesore for years and the petitioner is seeking to turn the building into a quality auto repair shop. The property was last used as a Midas Muffler shop so the proposal is for the same type use. Plans for the building include resurfacing and repainting the front and removal of all plywood and replacement of glass. Outdoor lighting on the utility pole will be downward facing towards the building and away from the street and abutting neighbors. A 6' high fence on the eastern boundary will be installed as directed by the Planning Board. The broken pole sign will be removed and the front lot will be repaved. The overhead doors have already been replaced and there will be no new construction. The adjacent property to the east has been secured to meet zoning requirements for 18 parking spaces. A topographical study was submitted and the drainage issue in the rear of the property has been taken care of by tying in the downspout to the storm sewer. The receiver in the front lot has been replaced which took care of the standing water issue. Town Engineer David Johnson has approved the engineering.

Councilman Hanley thanked Mr. Steiner for taking on the project and cleaning up the property. He commented on lack of a sidewalk on the east side of the property and questioned if Mr. Steiner was willing to install 20' of sidewalk. Mr. Steiner stated he planned to either have a paving contractor put blacktop there or have a concrete contractor install a sidewalk on the east side.

ISSUES OF THE PUBLIC

- A Mill Road resident commented on the following:
 - ✓ Suggested a petition be circulated to present to Governor Cuomo regarding the decrease in local funding Supervisor Meegan stated she will be meeting with state legislators on Wednesday to get something together on this issue.
 - ✓ Thanked the Town Board for the blinking yellow signal on Ridge Road; suggested the signal on Orchard Avenue and Union Road be changed to blinking; stated the yellow flashing light at Southgate Plaza is a distraction Chief Denz noted the light at Orchard Avenue and Union Road is a trip signal.
- An Indian Church Road resident commented/questioned the following:
 - ✓ Cost of electrical inspector position being changed from part-time to full-time; noted the person holding the position does not hold a masters electrical license in town
 - ✓ Referred to town/county tax bill that states increase in General Fund is 8.8 percent Councilman Hanley replied the overall tax increase was approximately three percent.
- A Leydecker Road resident that previously addressed the town regarding a neighboring tree problem stated the dead trees are still on the property and expressed concerns that they will fall on her house with the upcoming weather conditions. Code Enforcement Officer Jeffrey Baksa responded he will make phone calls in the morning and asked the resident to contact him tomorrow.
- An employee of Republic Services commented on the change in the recycling market which caused bid documents to have to be rewritten. He stated that typically there is a pre-bid procedure to allow potential bidders to review the documents, but the town did not do this. He believes there were significant irregularities in the bid and the services should be rebid. Town Attorney Tina Hawthorne stated she met with Republic Services on January 2, 2019 and they never stated anything about bid irregularities. At that time, they wanted to amend their bid after the bidding process was closed because their proposal indicated one thing and they sought to reduce by half the number in Part B for fixed fees and processing of recyclables. Mrs. Hawthorne stated the timing in which this was brought to the town's attention did not allow for the contract to be rebid. The contract expires January 31st and they cannot get an extension on the current services because the Town Board is not willing to violate General Municipal Law. Mrs. Hawthorne further suggested Republic Services have their attorney review General Municipal Law Section 103.
- A Covington Drive resident commented on the meeting room chairs having rollers and the potential for injury. Supervisor Meegan stated she is looking into getting stoppers for the chairs.

Whereas, the Town Board of the Town of West Seneca received a request for a rezoning and special permit for the following described property located at 1412 Ridge Road from its classification of C-1 to C-2(S) for an automotive repair shop:

All that tract or parcel of land, situate in the Town of West Seneca, County of Erie and State of New York, being part of Lot 289, Township 10, Range 7 of the Buffalo Creek Reservation and according to a map filed in the Erie County Clerk's office under Cover No. 1193, known and distinguished as Lot 34, 35, 36 & 37.

Whereas, this Town Board held a public hearing on the 28th day of January 2019 at 7:00 P.M., EDT in the Community Room, 1300 Union Road, in said town, to consider granting a rezoning and special permit for the above-described property; and

Whereas, at such time and place this Town Board did meet to hear any and all persons interested in the subject thereof concerning the same.

Now, therefore, be it resolved, that a rezoning and special permit is granted and the same is hereby rezoned from C-1 to C-2(S), conditioned upon installation of a 6' high board on board fence on the west side setback 30' and extending the entire length to the rear corner and sidewalks to be installed on the east side of the building; and

Jacqueline A Felser West Seneca Town Clerk WHEREAS, Governor Cuomo's proposed 2020 NYS budget includes unprecedented cuts to unrestricted state revenue sharing program known as Aid and Incentives to Municipalities (AIM) in the amount of \$49 million, effectively eliminating the program; and

WHEREAS, funding has not been increased in the last several years as unfunded mandates and cost of town and village services have risen; and

WHEREAS, if these cuts go through, a shocking 91 percent of towns and villages will permanently lose their AIM funding; and

WHEREAS, incentives for shared services, consolidation and infrastructure remediation directed by consent orders in no way replace the needed financial assistance to fund and manage the increasing costs of day to day services and capital projects needed in sustainable town and village planning and management; and

WHEREAS, the proposal to eliminate AIM funding unfairly punishes state residents, making financial planning aligned with the NYS Tax Cap virtually impossible; and

WHEREAS, the Governor is proposing to make the Tax Cap permanent, discontinue the \$65 million in Extreme Winter Recovery Program and proposes no increase for CHIPS funding, for which there has been widespread vocal support; and

WHEREAS, the proposal to eliminate AIM funding is not proactive, but a method to cut a small percent from the state budget, yet a significant amount of revenue to town and village budgets; now, therefore, be it

RESOLVED, the Town of West Seneca along with the Association of Erie County Governments strongly opposes the elimination of AIM funding; and be it further

RESOLVED, the AIM funding benefits all of our residents not only in Erie County but throughout New York State and eliminating it could result in services, program cuts and layoffs; every dollar that the state shared is a dollar that doesn't have to be levied on the backs of the taxpayers; and be it further

RESOLVED, that a certified copy of this resolution be forwarded to Honorable Governor Andrew M. Cuomo, Honorable Speaker of the Assembly Carl E. Heastie, Honorable Senate Majority Leader Andrea Stewart-Cousins, Honorable Majority Leader of the Assembly Crystal People-Stokes, Erie County Executive Mark Poloncarz and Erie County Legislator Joseph Lorigo.
