ISSUES OF THE PUBLIC

- A Covington Drive resident questioned/commented on the following:
 - ✓ How many members are being sought for the proposed budget committee Supervisor Meegan responded no number has been set.
 - ✓ Status of amendment to Town Code concerning Industrial Park Review Committee Supervisor Meegan responded the item was received and filed and will be back on the agenda at a future date.
 - ✓ Amount of the town's contribution for the East & West Road sewer project Supervisor Meegan responded the town's contribution is about \$679,000 and it is being bonded with Sewer District #13 paying on the bond.
 - ✓ Status of the pump station at Sewer District #5 Supervisor Meegan responded the pump station is up and running and the cost of the repair is approximately \$200,000.
 - ✓ Cost of the repair of the broken sewer line Supervisor Meegan responded the cost was approximately \$200,000.
 - ✓ Cost to rebuild the hill side at the end of North Covington Drive Supervisor Meegan responded they have not yet received the bill, but it will be part of the warrant with the cost being paid by Sewer District #5. Councilman Hanley added the Town Board will be reaching out for help with the cost of repairs.
- An Indian Church Road resident questioned/commented on the following:
 - ✓ What engineering firm approved the pump station and the electric panel Councilman Hanley responded Clark, Patterson, Lee is the engineering firm and the building flooded which destroyed the electric panel.
 - ✓ Cause of the sewer line break along North Covington Drive Councilman Hanley responded the ice and water eroded the bank and the sewer was left free hanging and collapsed upon itself.
 - ✓ Commented on the wind storm and questioned if any electric poles were lost -Councilman Hanley stated he called this morning and there were no poles down. Highway Supt. Matthew English stated he since received a call on one pole. He further clarified the town is only responsible for poles that have a town light on them; if there is anything else electrical on the pole, the town is not responsible.
 - ✓ Stated his town & county tax bill reflects an 8.8 percent general town tax increase Supervisor Meegan responded the 8.8 percent is the increase in the levy between last year and this year, not the tax rate increase.

ISSUES OF THE PUBLIC

Mark Kulik of Tilson Technology spoke on behalf of Verizon concerning a lease agreement with the town for property behind the pump station on Constitution Avenue. Verizon would like to place a utility pole with communications equipment, including a 2' tall antenna, on the top of the pole along with a small box. Mr. Kulik stated the antenna will enhance Verizon's communications network and provide more wireless broadband to homes in the area, which based on usage are in need of additional capacity. Maintenance on the equipment will only be performed about once each year. Supervisor Meegan requested Mr. Kulik notify the neighbors as a courtesy and the item will be placed on the agenda for the March 11, 2019 meeting.
