PRESENTATION BY NYS DEPARTMENT OF TRANSPORTATION (NYSDOT)

Representatives from the NYS Department of Transportation provided the following information on the Clinton Street project that will take place next year:

- the project will start at the Buffalo city line and extend through the Town of West Seneca to Two Rod Road in Marilla
- Clinton Street will be milled and resurfaced; pedestrian facilities will be upgraded ensuring curb ramps are ADA compliant; some signal systems will be improved
- drainage issues will be addressed and the culvert near Canisius High School athletic field will be replaced
- bid opening will take place in March 2020; project completion is winter 2021

Councilman Hart suggested an additional traffic signal on Clinton Street between Union Road and Borden Road. NYSDOT responded the town could request a light at a specific location and a traffic study would be done to see if the location warrants installation of a signal. Councilman Hart also questioned if the project will be done at the same time as the Transit Road bridge project at Southwestern Blvd. NYSDOT stated they first have to determine if the Transit Road bridge will be rehabilitated or replaced before moving forward with recommendations.

ISSUES OF THE PUBLIC

- A resident referred to the revised Code of Ethics and suggested the following:
 - ✓ §13-2 Definitions the term "Interest" should include parent and grandchild
 - ✓ §13-4 Penalties Suggested an alternative independent party when a board member is involved
 - ✓ §13-3(D) If a Town Board member recuses from voting on a matter, they should also recuse from voicing an opinion on the matter.
- A resident questioned if there is a revised estimate for litigation costs on the Burchfield Center repairs – Town Attorney Tina Hawthorne stated it is difficult to estimate the cost of litigation, especially in the appeal process.
- A resident questioned if the revised Ethics Code addresses appointed members of various boards and referred to an issue that was before the Planning Board a few years ago where three members including the Chairman had to recuse themselves from voting, yet the Chairman continued to lead the meeting. Town Attorney Tina Hawthorne stated the new code addresses conflicts of interest with disclosures in place and suggested the resident present his opinion on how this situation should be addressed in the code at the upcoming public hearing.
