- A resident referred to the WNY Law Center agreement and questioned the following:
 - ✓ Who receives the 500 brochures that will be distributed and who puts the brochure together Supervisor Meegan responded grant funding pays for the program and the law center puts the brochure together. People in need are identified by their own reach or by recommendation of the banking industry.
 - ✓ What does the task force do for residents Councilman Hanley stated the task force works directly with the banks and Code Enforcement Office, transferring addresses back and forth while working as a conduit between the banks, the town and the county to keep residents in their homes. The WNY Law Center will be at the November 4th work session with a presentation. Town Attorney Tina Hawthorne stated WNY Law Center is also helpful in keeping mortgage companies accountable for properties should a home become vacant.
 - ✓ What does the town do with the information Councilman Hanley stated the data base is shared with County Clerk Michael Kearns. Approximately six years ago there were 99 zombie homes in West Seneca and today the town is down to 23.
