Ms. Hawthorne and Supervisor Dickson have had conversations regarding the impartiality of the Town Attorney and not being a participant in partisan campaigns - the Town Attorney represents the entire Town Board and Supervisor Dickson is sure Ms. Hawthorne will do as such.

Councilman Piekarec expressed his concerns regarding the town being with Clark, Patterson and Lee for the past six years; being a new Town Board, there was not a practical way to bid this service.

Supervisor Dickson stated he believes all the contracts with the town should be examined and rebid if necessary - there was simply not enough time to conduct a formal Request for Proposal.

Councilman Hanley stated currently there is a professional services agreement with Clark Patterson and Lee that guarantees the company \$75,000 capped at \$125,000 per year; anything beyond \$125,000 would need an agreement and Town Board approval to exceed the amount. This contract is for normal engineering services and anything beyond (i.e. pipe breaking in Cazenovia Creek) is extra and not part of engineering services and would come out of the \$50,000 contingency budget.

On the question, Councilman Hanley stated the Supervisor hasn't been included in this motion in many years and he believed the last Supervisor to receive health insurance was former Supervisor Paul Clark. Supervisor benefits have not been budgeted for this year; although he is in agreement with the motion, the Supervisor should be removed.

Councilman Bauer stated the Supervisor position did not have healthcare benefits for the past eight years; the approved budget for 2020 does not have finances allocated for this additional cost. The cost of the additional health care benefit to the Town of West Seneca would be over \$25,000 per year, equivalent to a wage increase to the Supervisor to over 38%, only two days into office. Councilman Bauer further stated he is in opposition of the Supervisor receiving the benefits.

Councilman Cantafio stated he understands the budget concerns of Councilman Hanley and Councilman Bauer; however, he believes full time employees deserve quality health care.

Councilman Piekarec stated adding the benefit may attract more people to the position in the future.

Supervisor Dickson responded the former Supervisor was given the opportunity to receive the benefits and the wording was taken out approximately two years into her term. Although she did not receive benefits at that time, she picked the in-lieu-of option under the white collar contract. Supervisor Piotrowski, Supervisor Clark, surrounding Town Supervisors and every full time employee receives health insurance. If we want to attract people to run in the future, every full time employee should be treated the same. The former Supervisor was covered by her husband being an employee of the town. Per the contract only one person may receive the benefits.

Councilman Hanley stated he is not here to debate the former Supervisor; she did not receive the benefit or the stipend. The stipend was removed while Councilman Rusinski was on the Town Board. The former Supervisor received benefits the same as if she would have been a stay at home mom through her husband and she never took the stipend. There is not \$28,000 budgeted for Supervisor benefits this year.

Supervisor Dickson replied as per the minutes from 2013 Supervisor Meegan did receive the benefits. To not give the benefits to a full time employee who does not have a spouse working for the town would be a first time occurrence.

  - e. West Seneca Highway Superintendent is authorized to request aid from other towns in Erie County. Non-West Seneca personnel and equipment will work under the supervision of the West Seneca Highway Superintendent.

#### Rules of Order of the Town Board of the Town of West Seneca.

- 1) The Supervisor\* shall preside at all meetings of the Board and shall preserve order and decorum in debate.
- 2) The Supervisor, immediately following the opening of every regular meeting of the Board, shall proceed to the regular order of Town business as follows:
  - a) Call to Order
  - b) Pledge of Allegiance
  - c) Roll Call
  - d) Fire Prevention Code
  - e) Approval of Minutes
  - f) Announcements
  - g) Reports of department heads
  - h) Public comments/questions on agenda items
  - i) New Business
  - i) Old Business
  - k) Issues of the public.
  - l) Adjournment
- 3) Public Hearings: It shall be the duty of the Supervisor to preside at all general or special business hearings and to instruct all persons addressing the Board to state their names and addresses and to request those in favor of the proposal before the Board to speak first and those in opposition to speak last. At such hearings the Board may by special rules prescribe the time to be allotted to each speaker and the number of times each speaker may speak.
- 4) At the close of the public hearing as provided for in paragraph "3" above, the Supervisor may grant any member of the general public in attendance at such meeting a reasonable opportunity to be heard on any question or subject in which the Town or its government is concerned.
- 5) Every resolution or motion must be seconded before being put to a vote by the Supervisor, and all resolutions or motions shall be recorded in their entirety in the official minutes of the Town Board.
- 6) The Supervisor may offer or second a resolution or a motion and need not relinquish the chair for such purpose.
- 7) No motion or resolution may be brought to a vote except by the majority consent of those present, unless printed or typewritten copies thereof are presented to each member of the Board 48 hours prior to the opening of the meeting at which such motion or resolution is offered.
- 8) When a question is under debate, no motion shall be entertained unless (a) for an adjournment or recess, (b) for the previous question to lay on the table, (c) to postpone, to refer to a committee, or (d) to amend. These latter motions are neither amendable nor debatable.
- 9) No motion shall be made to offer any amendment to an amendment already before the Board on any proposition.
- 10) A majority vote of all the members of the Board shall be required to suspend these rules of order. A majority of the Board shall constitute a quorum.
- 11) If the above stated rules are, or become at any time, in conflict with the statutory law, the statutory law shall take precedence.
- 12) No member of the public shall engage in any demonstration, booing, hand clapping or otherwise disrupt the formality of a town board meeting.

- 13) Any persons speaking to the Board shall address their remarks to the Board, not to other members of the audience in the form of a debate.
- 14) Town Board members shall not attempt to answer questions during the time that a speaker is presenting during public comment periods. Town Board members will note any questions asked and may respond to the speaker at the conclusion of the speaker's public comments. Questions from the public shall be answered by members of the Town Board or, if authorized by the Supervisor, by a department head.
