### 19-B COMMUNICATIONS FOR DISCUSSION

 Supervisor Dickson re Use of Recreation Funds

Supervisor Dickson stated there is a fund dedicated for recreation use that has a balance of \$280,000. This fund accumulates from new construction projects that include recreation fees. The purpose of this discussion is to obtain feedback from the public.

Councilman Hanley stated there are limitations for the use of the funds and it does not need to be spent at this point. There have been many ideas suggested including baseball, sidewalks, bike paths, and bike parks.

Councilman Piekarec stated he took a poll through Facebook and listed the top three suggestions received: replace playground equipment, do nothing, and adding a splash pad.

Residents offered the following suggestions:

- ✓ Pickle ball courts that could grow into leagues that would bring income to the town
- ✓ Pump track and Terrain Park presented by the West Seneca Bikes Group
- ✓ Improvements and maintenance to the Burchfield Nature and Arts Center presented by Friends of the Burchfield
- ✓ Invest in the parks near the Buffalo city line for underprivileged children Supervisor Dickson stated that area of town is eligible for CDBG money
- ✓ Funding recreation program registration costs for low income families Councilman Hanley stated discounts are available based on income levels established by the county
- ✓ Upgrades to the park near Fisher Court Councilman Hanley stated Fisher Court has been expanded three times but the park equipment has never been upgraded
- ✓ West Seneca Youth Baseball Association would like a pavilion at the Harlem Road Park
- ✓ Invest in the ice rink as it brings income to the town
- ✓ Use the money in the parks not the Community Center and Library building
- ✓ West Seneca Girls Softball Association would like artificial turf for at least two fields at Sunshine Park noting they have always paid a recreation fee to the town for every participant

Supervisor Dickson stated he would like to finish the second floor in the Community Center and Library, move town offices to the upper level and open up the lower level for community use. The Recreation Department would be able to hold programs year round in the additional space.

Supervisor Dickson and Councilman Bauer stated they are looking at converting the mushroom and wading pool into a splash pad. As splash pads do not require life guard supervision, Councilman Bauer stated the annual savings from life guard salaries at the wading pool would be \$45,000 - \$50,000 per year; the project would pay for itself over four to five years. A resident stated the splash pad at Cazenovia Park is always busy; a splash pad would be a great idea.

Councilman Piekarec stated there have been many suggestions received and he is not in favor of using the funds on the Community Center and Library building.

Supervisor Dickson stated he would like to see a recreation plan put in place so future budgets can be adjusted accordingly.

Councilman Piekarec stated the fund doesn't grow too much from year to year as it is dependent on new construction in the town. The fund has been used for a \$2,500 payment for an extra soccer field.

Councilman Piekarec stated the CDBG money can be used for purposes other than the milling of roads.

Supervisor Dickson stated the suggestions will be taken into consideration and the conversation will be continued while noting the groups that demonstrate the need and proposed cost of their projects make a stronger argument for receiving funds.

2. Town Attorney re Creation of Internal Audit Committee

Motion by Supervisor Dickson, seconded by Councilman Hanley, to adopt the following resolution for the creation of an Internal Audit Committee in the Town of West Seneca:

WHEREAS, the Town of West Seneca (hereinafter referred to as "Town") recognizes that it desires to increase its internal controls over financial transactions involving the Town by the creation of an Internal Audit Committee; and

WHEREAS, it is the responsibility of such a Committee to provide independent review and oversight of the Town's financial reporting processes and internal controls; and

WHEREAS, the Town Board has determined that creation of the Internal Audit Committee is for the benefit of the taxpayers; and

WHEREAS, the creation of this Internal Audit Committee in no way limits the powers or responsibilities of the Town Board as it relates to any internal auditing; and

NOW THEREFORE, be it resolved that the Town of West Seneca hereby creates an Internal Audit Committee as follows:

- 1. The Committee shall consist of three (3) total members. Of those three (3) members: 1) Two (2) Town Board Councilpersons shall be appointed to the Committee by the Town Board, and 2) One (1) resident of the Town shall be appointed by the Supervisor.
- 2. The two (2) Town Board Councilpersons shall each be appointed for a period of two (2) years in staggered terms. The initial appoints shall expire on December 31, 2021 and December 31, 2022, and bi-annually thereafter. In the event a Councilperson leaves office or resigns from the Committee prior to the expiration of their term, another Councilperson shall be appointed to fill the vacancy for the length of the unexpired term. The Town Board Councilpersons shall not be permitted to serve consecutive terms. The resident of the Town appointed to the Committee shall serve at the pleasure of the Supervisor for an indeterminate period of time.
- 3. The Town Board shall appoint one of the two (2) Town Board Councilpersons as the Chair of the Committee and shall further appoint a secretary to the Committee.

- 4. The Committee shall meet on a monthly basis. Fourteen (14) days prior to the each meeting, the Committee shall notify the Town of West Seneca Director of Finance what two vendors or what single budget line they plan to review at the meeting. Seven (7) days prior to each meeting, the Town of West Seneca Director of Finance shall provide the Committee all requisitions, purchase orders, and invoices, including authorizations, for either a minimum of two Town of West Seneca vendors or for a single budget line for the previous six (6) to twelve (12) months. Said information may be provided to the Committee electronically.
- 5. Once annually the Committee shall dedicate a meeting for the sole purpose of reviewing all credit card activities by the Town for the prior twelve (12) months or since the date of the last review by the Committee, whichever is shorter.
- 6. The Committee shall review the vendor materials provided by the Town's Director of Finance and determine if transactions are in compliance with the Town of West Seneca Procurement Policy and/or paid in accordance with any applicable contract(s). The results of the monthly review shall be reported to the Town Board and Town of West Seneca Finance Director. The Committee shall present annually to the Town Board a written report of how it has discharged its duties and met its responsibilities. Said reports shall be made available to the public.
- 7. The Committee shall meet with the Town of West Seneca's external auditor before and after the annual audit to discuss any Committee findings relevant to the annual audit.
- 8. The Committee shall be subject to the New York State Open Meeting Law. Minutes shall be taken at each and every meeting, and such minutes shall identify the vendor(s) and a summary of the document review for each vendor as more fully described above.
- 9. No member of the Committee shall be compensated by the Town for their work on the Committee.

Supervisor Dickson would like the Town Board to consider creating an Audit Committee of the Town Board to review the practices being followed by the board; it would consist of two council members and one resident preferably a CPA. Supervisor Dickson envisions monthly meetings whereby a few vouchers are audited.

Councilman Piekarec suggested having a larger committee consisting of three residents and two board members.

### **ISSUES OF THE PUBLIC**

- A resident expressed frustration with NYS COVID-19 policies
- A resident, who is a CPA, commented on the proposed Audit Committee:
  - ✓ Legal counsel should consider the following commissioners coverage, scope of work, chain of command, client privilege, and potential conflicts of interest
- A resident from Leydecker Road requested assistance from the Town Board regarding a dispute with a neighbor operating a business on adjacent property
- Members of the Citizen's Budget Advisory Group commented on the following:
  - ✓ Members are committed to what is best for West Seneca
  - ✓ Offended by Councilman Bauer's comment that they be more transparent
  - ✓ Met with many town department heads throughout the process
  - ✓ Addressed Councilman Cantafio's comments from a newspaper article and stated council members were able to attend meetings Councilman Cantafio reminded the member that he expressed his gratitude to the group at the previous Town Board meeting; he was not critical of the committee merely he was not sure of its intent

Councilman Bauer offered an apology for any member that was offended and referred to the previous year's Budget Committee that held public meetings in accordance with the Open Meetings law. Supervisor Dickson clarified this is not a government entity but a group of volunteers that offered a wide range of expertise.

- The following questions were received through Facebook:
  - ✓ Who is responsible for sidewalk repairs due to tree roots from a tree the town had planted and can the property owner cut the tree down — Highway Superintendent Adams stated the property owner is responsible for sidewalk repairs and taking a tree down would require his approval.
  - ✓ Are extra recycling totes available Supervisor Dickson recommended residents be certain that the items are, in fact, recyclable before purchasing an additional tote as this may alleviate the amount of items placed in the tote. Highway Superintendent Adams stated recycling is a business and when it is not profitable items are not accepted and are transported to the landfill at the town's cost.
  - ✓ Was the second floor of the Community Center and Library supposed to be completed by town employees and what is the status – Councilman Hanley stated it was the intention that town employees would complete the work; this has not been completed at this point.
  - ✓ Can the Town Board move forward with reducing the speed limit on Covington Drive from 35 mph to 25 mph Supervisor Dickson has reached out to the state and anticipates the Town Board will pass a resolution in support of this. Highway Superintendent Adams explained speed limit changes must go through the county and then the NYS Department of Transportation for

- ✓ final approval. Councilman Piekarec stated the population of the town is under the threshold that would allow the town to make the change on its own.
- ✓ What is the legal limit of dogs and why is it not enforced Highway Superintendent Adams stated there is a two dog limit; he asked the resident to follow up with him regarding the situation in question.
- ✓ What is the status of replacing the town sign Councilman Hanley said the insurance companies are still reviewing the situation. Town Attorney Hawthorne stated the status of the claim is being held up but the amount of the insurance payout will not fully cover the cost of replacing the sign. Supervisor Dickson stated he will try to include the cost of the sign into the 2021 budget. Councilman Piekarec suggested a non-digital sign might be less expensive.
- ✓ Councilman were aware of the Citizen's Budget Advisory Group, in January and felt their comments were political

West Seneca will also have a task force in the near future and asked the council members to offer candidates for participation; results of these efforts are due by April 1, 2021, or the municipalities risk losing state aid.
