### **HELD OVER PUBLIC HEARING**

1. Re "ADOPTION OF THE 2021 TENTATIVE BENEFIT BASIS BUDGET & 2021 TENTATIVE AD VALOREM BUDGET" in the Town of West Seneca received and filed.

Emails were received from residents with the following comments:

- Support recommendations to keep the Sanitation and Police Departments staffed to maintain the health and safety of the town
- Provide pay increases for all employees in the spirit of fairness
- Buildings & Grounds employees provided a sense of normalcy by preparing and keeping the ball diamonds open and playable; played an important role for the youth aspiring to earn athletic scholarships
- Retirees may need to re-enter the workforce to afford tax increases
- No tax increase is greatly appreciated and unprecedented

Supervisor Dickson, Councilman Hanley, and Councilman Piekarec have submitted changes to the budget that have no net effect.

Director of Finance Megan Wnek stated the town received an updated assessment which decreased the town's assessed value by \$607,000; this has added an additional \$13,291 to be addressed. The changes being presented do address this amount.

Attached are amendment proposals from Supervisor Dickson, Councilman Hanley, and Councilman Piekarec.

Supervisor Dickson addressed Councilman Hanley's reduction in the HR Consultant line and stated the entire Town Board agrees that it is a good idea to review the current set up. Regardless of the solution there will be costs involved and it is not realistic to assume the current provider would work for a third of their current rate.

Councilman Piekarec stated he does not support a cut in the HR line. There is a wage freeze to any employee not covered by a collective bargaining agreement and is not in favor of raises.

Supervisor Dickson stated in 2021 only thirty-five to forty employees are contractually required to get a raise; choosing seven people out of the group of one hundred sixty people not getting a raise would not be fair.

Councilman Hanley stated the seven employees have always enjoyed the same benefits of the White-Collar Unit. The HR company has not earned the \$84,000 they are collecting this year.

Supervisor Dickson stated he understands the problems with the current HR company but there needs to be money in the budget line for HR in 2021.

Councilman Cantafio questioned if Ms. Wnek has an estimate for an hourly rate for HR services and what services the HR company is currently performing. Ms. Wnek listed the services to include the onboarding process, drug screening – handled by Finance recently; termination letters for retirements – Finance has a template and can send; ACA reporting – can be tracked through Excel program inhouse; working on an Employee Handbook – the labor attorney has provided a template that can be updated inhouse; discipline – the Town Attorney gets involved in this process; benefits including health, dental, and vision - currently being handled by Finance; workers compensation is being handled by Finance and the Town Attorney; and Timeclock. Ms. Wnek believes employees need a face for HR, someone they recognize and can work with.

Councilman Piekarec questioned the number of hours per week Finance dedicates to theses HR functions. Ms. Wnek responded it is dependent on the time of year, for example, preparing for summer is very busy. Finance is currently acting as a liaison for employees reaching out to request a leave. Councilman Piekarec questioned what would be needed if the Finance Department absorbed the HR duties. Ms. Wnek estimated a part-time employee working twenty hours per week at \$20/hour would cost the town \$21,000 per year. Councilman Piekarec questioned if removing HR duties from the department heads would be desirable. Ms. Wnek suggested a discussion with all involved parties would be appropriate. Councilman Piekarec replied he prefers leaving the line funded.

Councilman Cantafio stated he would like to see a full time HR position at some point and asked Councilman Hanley how much it would cost to restore the part-time laborers. Councilman Hanley responded restoring the part-time Sanitation labors would be \$45,000 and restoring the part-time Buildings and Grounds laborers would be \$40,000. Councilman Hanley would like to see the current

departments continue performing the HR duties to free up the money in the HR budget line. Supervisor Dickson suggested leaving the HR budget line to allow for options.

Councilman Piekarec supports Supervisor Dickson's proposal that restores \$20,000 for Buildings and Grounds and \$22,000 for Sanitation. There is \$30,000 in the General Fund Contingency line and \$50,000 in the Highway Fund Contingency line that can be moved as needed.

Councilman Cantafio questioned if HR has regularly put in twenty hours of work. Ms. Whek stated they have not. Town Attorney Hawthorne stated it has been since October of 2019 that HR has put in regular hours.

Councilman Cantafio questioned Councilman Hanley's proposal to remove the full-time clerk position in the Town Attorney's office. Councilman Hanley stated the full-time clerk position has not been filled for eighteen years and does not need to be filled this coming year. Town Attorney Hathorne stated there are many Office of Court Administration regulations that have changed the responsibilities of the Town Prosecutors who fall under the Town Attorney's office. The current part-time employee can only work up to nineteen hours per week and she cannot be made seasonal. Ms. Hawthorne stated her department now needs to handle every plea by mail; this has shifted from the court office. Additionally, Ms. Hawthorne would like an assistant that has time to take on more duties. Supervisor Dickson stated the benefits of a full-time clerk would be continuity in the office of the Town Attorney and alleviate the clerical responsibilities of the Town Attorney.

Supervisor Dickson polled the Town Board about the proposal to remove the \$60,000 in the HR line. Councilman Cantafio requested leaving this tabled to explore the idea of a part-time position. Councilman Bauer would like to explore the part-time position.

Supervisor Dickson polled the Town Board about the proposal to fill the full-time clerk position in the Town Attorney's office. Councilman Cantafio and Councilman Bauer both stated they would like to review this item.

Supervisor Dickson stated there are important functions HR performs to keep the town in compliance. Councilman Cantafio is in support of maintaining some form of HR and will be able to vote after investigating the numbers.

Supervisor Dickson polled the Town Board regarding the raises for the seven employees proposed by Councilman Hanley. Councilman Bauer understands the seven employees in question have always enjoyed the White-Collar benefits and stated the Blue-Collar Unit and PBA are yet to be determined. Supervisor Dickson stated there is no raise for either unit in his 2021 budget. Councilman Cantafio agrees with the sentiment of Councilman Hanley but would like to look at the actual numbers involved before voting. Councilman Piekarec would like to look at the numbers as well.

Supervisor Dickson suggested Councilman Cantafio propose his own amendment at the next meeting. Councilman Cantafio will review the proposals and may propose an amendment.

Part 617.
- 2. The Board hereby determines the Proposed Action is a Type II action in accordance with SEQRA regulations.
- 3. No further review of the Proposed Action is required under SEQRA.
- 4. This resolution shall be effective immediately.

1 Town Attorney re Creation of Internal Audit Committee

Motion by Supervisor Dickson, seconded by Councilman Hanley, to adopt the following resolution:

WHEREAS, the Town of West Seneca (hereinafter referred to as "Town") recognizes that it desires to increase its internal controls over financial transactions involving the Town by the creation of an Internal Audit Committee; and

WHEREAS, it is the responsibility of such a Committee to provide independent review and oversight of the Town's financial reporting processes and internal controls; and

WHEREAS, the Town Board has determined that creation of the Internal Audit Committee is for the benefit of the taxpayers; and

WHEREAS, the creation of this Internal Audit Committee in no way limits the powers or responsibilities of the Town Board as it relates to any internal auditing nor does it relieve the Town Board from any obligation to be primarily responsible for management, control, and oversight of the Town's financial matters; and

NOW THEREFORE, be it resolved that the Town of West Seneca hereby creates an Internal Audit Committee as follows:

- 1. The Committee shall consist of five (5) total members. Of those five (5) members: 1) Two (2) Town Board Councilpersons shall be appointed to the Committee by the Town Board, and 2) Three (3) residents of the Town shall be nominated by the Supervisor and approved by the Town Board.
- 2. The two (2) Town Board Councilpersons shall each be appointed for a period of two (2) years in staggered terms. The initial appoints shall expire on December 31, 2021 and December 31, 2022, and bi-annually thereafter. In the event a Councilperson leaves office or resigns from the Committee prior to the expiration of their term, another Councilperson shall be appointed to fill the vacancy for the length of the unexpired term. The Town Board Councilpersons shall not be permitted to serve consecutive terms. The three (3) residents of the Town appointed to the Committee shall serve at the pleasure of the Town Board for an indeterminate period of time.
- 3. The Town Board shall appoint one of the two (2) Town Board Councilpersons as the Chair of the Committee and other as a secretary to the Committee.
- 4. The Committee shall meet on a monthly basis. Fourteen (14) days prior to each meeting, the Committee shall notify the Town of West Seneca Director of Finance what two vendors or what single budget line they plan to review at the meeting. Seven (7) days prior to each meeting, the Town of West Seneca Director of Finance shall provide the Committee all requisitions, purchase orders, and invoices, including authorizations, for either a minimum of two Town of West Seneca vendors or for a single budget line for the previous six (6) to twelve (12) months. Said information may be provided to the Committee electronically.
- 5. The Committee shall review all credit card activities by the Town every sixty (60) days.
- 6. The Committee shall review the vendor materials provided by the Town's Director of Finance and determine if transactions are in compliance with the Town of West Seneca Procurement Policy and/or paid in accordance with any applicable contract(s). The results of the monthly review shall be reported to the Town Board and Town of West Seneca Finance Director. The Committee shall present annually to the Town Board a written report of how it has discharged its duties and met its responsibilities. Said reports shall be made available to the public.
- 7. The Committee shall meet with the Town of West Seneca's external auditor before and after the annual audit to discuss any Committee findings relevant to the annual audit.
- 8. The Committee shall be subject to the New York State Open Meeting Law. Minutes shall be taken at each and every meeting, and such minutes shall identify the vendor(s) and a summary of the document review for each vendor as more fully described above.
- 9. No member of the Committee shall be compensated by the Town for their work on the Committee.
- 10. All members of the Committee shall abide by the Town of West Seneca Ethics Code, Whistleblower Policy, and Social Media Policy.

On the question, Councilman Cantafio understood that the entire Town Board would approve the three residents nominated by the Supervisor.
