Ralph Lorigo, attorney for the applicant Joseph Lowry, stated the property has been a commercial property since its construction over sixty years ago which predated the current zoning code. The new owner is an engineering group that will use 10,000-sf as office space and 4,000-sf for warehouse space with no commercial vehicles coming to the property. Mr. Lorigo noted the previous owner used the space in the opposite way and had tractor trailers come to the facility. The purpose of the application is to bring the zoning into compliance with the C-1 zoning and will allow the purchaser to obtain bank financing. The Planning Board gave this a unanimous recommendation.

Councilman Bauer referred the disposal of concrete cylinders and asked the new owners to be considerate of the neighboring properties and questioned if there will be any outside storage Mr. Lorigo stated the owners will be considerate of neighbors and there will not be any outside storage.

Councilman Piekarec questioned the hours of operation. Mr. Lorigo replied there will be normal office hours of 8 A.M. to 5 P.M. with the possibility of some employees staying later.

Code Enforcement Officer Schieber stated the surrounding property owners were notified of the zoning change and of the public hearing. The recommendation was made for C-1 zoning from the Planning Board which provides the future owners zoning compliance to secure funding and it protects the town, as the zoning of C-2 would allow for restaurants, bars, and the storing of construction equipment. The C-1 zoning is appropriate for this environment.

The property owner of 300 Main Street expressed concerns of the processing/warehouse space due to an increase in noise and traffic along with the safety of school students walking to and from the high school. Mr. Lorigo reiterated the new owner is an engineering firm, and the use is going to be substantially more office space with less noise and traffic. Code Enforcement Officer Schieber confirmed the enforcement of noise restrictions and this is a less intense use than what is there now.

Town Attorney Hawthorne noted the Planning Board recommended approval with no conditions.

1. Supervisor Dickson re Blue Collar Arbitration decision

Supervisor Dickson announced the arbitration decision stemming from a CSEA Blue Collar bargaining unit grievance concerning overtime pay during the COVID-19 state of emergency period was decided in the town's favor. This saved the town around \$500,000.

3. Town Attorney re West Seneca Chamber of Commerce, Inc. contract

WHEREAS, the Town of West Seneca (hereinafter referred to as "Town") recognizes that it requires professional services to plan, organize, coordinate and implement a variety of economic development related operations; and

WHEREAS, the West Seneca Chamber of Commerce's (hereinafter referred to as "Chamber") Mission is consistent with the Town's vision to promote economic development in the Town; and

WHEREAS, the Town desires to enhance continued efforts to expand its tax base for the benefit of the taxpayers by enlisting the services of a community economic development coordinator; and

WHEREAS, the Chamber possesses a variety of professional and technical skills to provide support to the Town by providing services to plan, organize, coordinate, and implement a variety of economic development related operations.

NOW THEREFORE, be it resolved that the Town Board of the Town of West Seneca authorizes the Supervisor to execute the Professional Services Agreement with the West Seneca Chamber of Commerce, Inc., for certain professional services related to planning, organizing, coordinating, and implementing a variety of economic development related operations for the 2021 calendar year.

4. Town Attorney re 2021 Real Property Tax Exemptions

Motion by Supervisor Dickson, seconded by Councilman Hanley, to adopt the following resolution as it relates to real property tax exemptions for 2021:

WHEREAS, on March 7, 2020, Andrew M. Cuomo, Governor of the State of New York issued Executive Order Number 202, declaring a State disaster emergency for the entire State of New York; and

WHEREAS, on December 18, 2020, the Governor issued Executive Order 202.83, a portion of which includes a local option pertaining to Senior Citizens' and Persons with Disabilities' partial property tax exemption, Subdivisions 7, 7-a and 8 of Section 459-c of the Real Property Tax Law (Partial Tax Exemption for Persons with Disabilities), and Subdivisions 5, 5-a, 5-b, 5-c and 6 of Section 467 of the Real Property Tax Law (Partial Tax Exemption for Low Income Senior Citizens), to the extent necessary to permit the governing body of an assessing unit to adopt a resolution directing the assessor to grant exemptions pursuant to such section on the 2021 assessment roll to all property owners who received either of those exemptions on the 2020 assessment roll, dispensing with the need for renewal applications from such persons, and further dispensing with the requirement for assessors to mail renewal applications to such persons; and

WHEREAS, the Town is desirous to adopt such resolution while also allowing the Assessor to require a renewal application to be filed when the Assessor has reason to believe that an owner who qualified for the exemption on the 2020 assessment roll may have since changed primary residence, added another owner to the deed, transferred the property to a new owner, or died; and

WHEREAS, the state disaster emergency has resulted in limited hours in municipal offices and rendered seniors and individuals with disabilities homebound and/or without the ability to file their real property tax exemption applications in person due to safety precautions and lack the ability to file such applications online; and

NOW,THEREFORE, BE IT RESOLVED, the Town Board of the Town of West Seneca hereby directs the Town Assessor, pursuant to the NYS Governor's Executive Order 202.83 Continuing Temporary Suspension and Modification of Laws relating to the pandemic disaster emergency, specifically as it pertains to Senior and Disability Exemptions, Section 467 and 459c of the Real Property Tax Law, to grant exemptions on the 2021 Assessment Roll to all property owners who received that exemption on the 2020 Assessment Roll, except in the case when the Assessor has reason to believe that there is a change of status that would no longer qualify the homeowner, thereby dispensing with the need for renewal applications from such persons, and further dispensing with the requirement for assessors to mail renewal applications to such persons.

On the question, Town Assessor Finbar stated this is an executive order that exempts low income seniors and low income disabled residents from having to submit applications unless there have been changes in ownership or a death that affects their income. The exemptions received last year will carry over until September.

Councilman Piekarec stated he is not in favor of paying employees not reporting to work; there are taxpayers who had to make their own childcare arrangements.

Councilman Cantafio stated he is in favor of looking into helping employees as it was irresponsible of the federal government to not follow through. This is a once in a lifetime pandemic.

Councilman Bauer questioned how many employees are affected. Town Attorney Hawthorne stated it is currently two; the employees work in the Court Office and cannot work from home due to the restrictions of Court Administration and New York State.

Councilman Hanley stated he supports helping the employees and extending the benefits through the end of March.

Councilman Piekarec speculated on the implications of the policy on employee's town wide.

Town Attorney Hawthorne confirmed it would be a town wide policy, noting it already was available town wide. One condition could be an employee must exhaust their sick time before the benefit would begin. This is expected to be a short term issue.

Supervisor Dickson acknowledged many good points have been offered and would like Town Attorney Hawthorne to draft a policy for the Town Board's consideration.
