business at 2604 Seneca Avenue, Niagara Falls, NY 14305, for the approval of a renewal agreement for Charter's cable television franchise for fifteen (15) years commencing with the date of approval by the Public Service Commission.

The franchise renewal agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, as amended, and certain court rulings.

A public hearing was held in the Town of West Seneca, New York on February 8, 2021 at 6:00 P.M. and notice of the hearing was published in the West Seneca Bee on February 4, 2021.

NOW, THEREFORE, the Board of the Town of West Seneca finds that:

- 1. Spectrum Northeast, LLC has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and
- 2. Spectrum Northeast, LLC has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and
- 3. Spectrum Northeast, LLC can reasonably meet the future cable-related community needs and interests, taking into account the cost of meeting such needs and interests.

BE IT FURTHER RESOLVED that the Board of the Town of West Seneca hereby grants the cable television franchise of Spectrum Northeast, LLC and the Town of West Seneca for fifteen (15) years commencing with the date of approval by the Public Service Commission and expiring fifteen (15) years hence.

BE IT FURTHER RESOLVED that the Board of the Town of West Seneca hereby confirms acceptance of this franchise renewal agreement and authorizes the Supervisor to sign the Agreement.

Hawthorne requests the policy be received and filed. Further, a proposed memorandum of agreement has been drafted and submitted to the White Collar bargaining unit which offers the flexibility of taking one day per week unpaid without having to exhaust their vacation, sick, or personal leave time. Ms. Hawthorne is withdrawing the Families First Coronavirus Leave Policy. Town Attorney Hathorne further addressed the public comment and stated the pay was at two-thirds, not full pay.

Councilman Cantafio stated the two employees never said they wanted to get paid for not working.

- Supervisor Dickson re Communications from Erie County Executive
 - ✓ The town does not have an official representative on the Erie County Environmental Management Council, (ECEMC), West Seneca Environmental Commission Chairperson Evelyn Hicks will find a candidate
- Supervisor Dickson re Communications from Erie County Comptroller received and filed.
- Supervisor Dickson re Union Road Improvement
 - ✓ NYSDOT is going to work on Union Road in April 2022 and queried the town about improvements
 - ✓ improve the street scape of Union Road in front of the West Seneca Town Hall and Community Center
 - ✓ on street parking is not allowed, but a raised median would be allowable
 - ✓ Comprehensive Plan was approved in 2016 and a Union Corridor study was ordered in 2017 would like to follow up with action on the investment

Councilman Piekarec stated he would rather spend town money on sidewalks, bike paths, or repaving more streets. If the board decides to go forward with the median, Councilman Piekarec suggested borrowing money to spread the cost over several years.

Councilman Hanley commented on the results of the traffic study stating Union Road was identified to be a cut through for most vehicles with the vehicles rate of speed being about five mph over the limit. Slowing traffic, creating a walking area, and establishing a town identity at the Town Hall campus were among the goals of the Comprehensive Plan.

Councilman Bauer expressed concerns that a median would impede access to businesses on the opposite side of the street. The project would need to be well planned and total commitment made as it would take a few years to complete.

- Town Attorney re Town of West Seneca sign
 - ✓ Accident at Union Road and Main Street in October 2019 that damaged the town sign
 - ✓ A claim was put through the driver's insurance and the town was awarded \$17,009.25 damage was estimated to be \$58,580
 - Councilman Hanley stated one of the sign companies that gave a proposal has reached out, offering to work with the town to provide almost the same sign quoted if the town helps out
 - Councilman Piekarec stated he has received feed back from residents that support replacing the sign as well as those who do not think a sign is needed and would like to see the expense held
