COMMUNICATIONS

Independent Contractor Disclosure Forms

Chairperson Teager reported on the meeting with Town Attorney Hawthorne, Finance Directors Ms. Wnek and Ms. Straus, and Ms. Greenan. It was decided that a packet including a cover letter, the disclosure form and request for a W-9 would be sent to new vendors paid by the town. There was discussion on the collection of the forms and differentiation between vendors and contractors; anyone who submits a W-9 would also submit a disclosure form. Further, it was clarified that the Town Attorney does not sign all contracts within the town. Due to this discovery, all Department Heads will be provided with the new vendor packet to obtain the disclosure forms.

Ms. Carpenter is in favor of the proposed process and suggested additional information be added to the Ethics Board's web page.

Chairperson Teager asked Mr. Kavanaugh if he had examples from the financial industry and if there were any elements that could be incorporated in the disclosure form. Mr. Kavanaugh offered two articles regarding political donations and shared personal experiences; this was for informational purposes. Ms. Carpenter offered examples from the banking industry.

Mr. Kavanaugh mentioned some meeting minutes from 2020 posted to the website are still "drafts." Secretary Martin will follow up on this item.

Ms. Carpenter questioned if the Ethics Board was going to investigate a social media policy. Secretary Martin advised there is a group comprised of Town Attorney Hawthorne, a Human Resources representative, Ms. Greenan, and Town Clerk Kobler currently preparing a policy. Ms. Carpenter requested the Ethics Board have the chance to review the policy upon its completion.
