Six years ago I bought a home here in beautiful West Seneca. I moved here due to proximity to work and the abundance of nature. The creeks, animals, and plenty of trees make our town appealing.

Over the years I learned to coexist with animals by safeguarding my landscape. I researched on my own and contacted animal experts. I make sure my garbage is secure and don't use animal feeding stations. As a result, the deer no longer browse my plants.

Nearby towns have been successful in educating the public on coexisting with wildlife. They provided residents with a plethora of information to help manage their property without using lethal methods. In turn, it deterred animals from leaving the woods and wandering into yards or roadways. Lethal methods are not successful, it only puts a bucket under a leaky faucet.
