## **PUBLIC COMMENTS ON COMMUNICATIONS**

- The following question was received regarding agenda item No. 1:
  - ✓ Is the \$25,000 being requested for the Burchfield Nature and Art Center intended to be an advance on the \$100,000 grant money that was sought and set aside in March 2020 Supervisor Dickson stated the town cannot spend any money until the state notifies the town the grant has been approved
  - ✓ What is the status on the structure, the public was told in June 2021 that measures have been taken to maintain the structure until grant money is received Councilman Bauer stated the deterioration is advancing, for example weeds and rodents in through the openings
  - ✓ Referred to statements from June when a structural engineer confirmed there was no additional deterioration and what had changed Councilman Bauer stated it is a concern for the winter weather. The only items that would be purchased are ones with long lead times, for example custom windows, and wanting to have the items on hand when town labor is available. Highway Superintendent Adams stated after the summer months he has more flexibility when scheduling his employees.

Councilman Bauer requested Agenda Item No. 1 be removed and requested ARP funding be used for this expense.

Highway Superintendent Adams stated he agrees with the need for repairs for the building along with ordering the materials now due to the current lead time for delivery.

Councilman Piekarec stated he is not in favor of raises for workers, many private sectors were laid off, had hours cut, took pay cuts; it sends the wrong message. Supervisor Dickson stated he agrees with Councilman Piekarec.

Supervisor Dickson stated there is not a rush to spend the money and the town has several years to spend the money. The need for sewer work is so great any amount not spent will probably be allocated to sewers.

Traffic Safety Committee recommendation for on-street RV parking

Highway Sup't. Adams stated he met with Chief Baker and Code Enforcement Officer Schieber to discuss the issues and agree with the safety concerns as well as aesthetics. The group decided it is desirable to not allow overnight parking and to move forward with their recommendation to create a code and local law banning overnight parking of recreational vehicles and trailers.

Councilman Hanley asked if the committee considered a parking lot for out of town visitors. Highway Superintendent Adams stated this was considered but was determined some residents may take advantage of town parking lots. The committee decided it was better to anticipate some people will violate the ban in those instances and address them as needed.

Motion by Supervisor Dickson, seconded by Councilman Hanley, to direct the Town Attorney to compose a draft law to ban on street parking of recreational and other large vehicles.

WHEREAS, the Town of West Seneca School District wishes to have School Resource Officers in place for the protection of school children; and

WHEREAS, Article 5-G of the General Municipal Law and Section 208-a of the General Municipal Law, the Town and the District are parties to a Municipal Cooperation Agreement, dated December 19, 2016, whereby the Town agreed to provide services of police officers employed by the Town and the District agreed to pay for said services during the period of January 1, 2017 through December 31, 2020; and

WHEREAS, the pursuant to Article 5-G and Section 208-a of the General Municipal Law, the Town and the District extended the terms of the Agreement for services to be provided during the period January 1, 2021 through June 30, 2021; and

WHEREAS, the students are returning to full-time, in-person schooling in September of 2021, and pursuant to Article 5-G and Section 208-a of the General Municipal Law, the Town and the District seek to extend the terms of the Agreement for services to be provided during the period July 1, 2021 through June 20, 2024l; and

NOW THEREFORE, be it resolved that the Town Board of the Town of West Seneca authorizes the Supervisor to execute the Municipal Cooperation Agreement School Resource Officers Between the Town of West Seneca and West Seneca School District extending the terms of the December 31, 2016 Agreement through the period July 1, 2021 to June 30, 2024.

On the question, Supervisor Dickson asked Chief Baker to comment on the program.

Chief Baker stated this was one of the pilot programs in New York State and the department currently has four officers in the schools full time for ten months with their salaries paid for by the school district.

Councilman Cantafio stated the positive impact is evident every day, the officers are not "security guards." The officers build relationships with the staff, students, and families.

Town Attorney Hawthorne stated the agreement is for five officers, one at each high school and middle school and one that is shared by the elementary schools; they are paid by the school district to the town according to the CBA contract noting the rates for 2024 will be determined. The agreement will be in place through June 30, 2024.

Supervisor Dickson noted the payments will be approximately: 2021 - \$286,000; 2022 - \$293,000; and 2023 - \$ 300,000.
