PUBLIC COMMENTS ON NEW BUSINESS

A resident referred to the contract with the new Town Attorney at \$65,000 and stated the smaller city of East Lansing, Michigan, spent \$300,000 to \$500,000 per year, and asked where additional funds beyond \$65,000 would come from. Councilman Piekarec stated the town may use difference between the prior salary and the savings of healthcare coverage. The resident asked if it was realistic to expect the cost not to exceed \$110,000 and what would happen if there was a conflict of interest. Councilman Piekarec stated labor law and assessment challenges are currently contracted out and the town has options if a conflict arises. Supervisor Dickson stated the town can adjust should a need arise. An item on the agenda will address the current residency restrictions to allow for a larger pool of attorneys that would be eligible for the town to select from. The resident referred to the Citizens Advisory Committee that reviewed this subject and asked if a study was ever done. Councilmember Kims stated that committee has not met in over a year. Supervisor Dickson stated he is confident this will save the town money and the town is getting a very capable attorney. Mr. Trapp explained his billing practices and reassured everyone that he will be attending all meetings.

1. Supervisor Dickson re Local Law No. 2022-01 – Expanding residency requirements for the positions of Town Attorney, Deputy Town Attorney, and Town Prosecutor

Supervisor Dickson explained this would allow an Erie County resident to be eligible to be the Town Attorney for West Seneca.

2. Councilmember Piekarec re Term limits – Councilmember Piekarec would like to re-introduce his proposal to the new Town Board members.

Councilmember Kims stated she would like to see the term limits set to two terms, excluding the Town Board members currently in the middle of their terms, and applicable to all elected positions.

Councilman Cantafio stated he does not oppose term limits but is still unsure if this should include all councilmembers and the Supervisor, or just the council members; another concern was the wording that could allow previous council members that served multiple terms to run again.

Supervisor Dickson stated he would not be opposed to Councilmember Kims version but there would have to be favorable public opinion to include the Town Clerk and Highway Superintendent positions. Councilmember Breidenstein stated he would support public opinion also, but his opinion was to not include the Town Clerk and Highway Superintendent positions in the term limits law.

Mr. Tanner explained the select demolition is an emergency and the Town Board needs to suspend some of the rules and requirements of a formal bidding process including compressing the timeline in which bids are received and advertising in the newspaper. The goal is to open bids on January 18, 2022 and bid documents will be available in an electronic form with the additional requirement that all potential bidders attend a pre-bid walk through at the demolition location. Mr. Tanner also stated the Town Board announced to the public during the special meeting this is an emergency.

Supervisor Dickson withdrew his motion.

Supervisor Dickson questioned Mr. Tanner on the status of the re-bidding of the Town Hall Sign replacement project. Mr. Tanner stated the Town Board did reject all bids from the second bid and he is working on changes to the specifications for the third bid and a new bid date will be set.

ISSUES OF THE PUBLIC

A resident had the following comments/questions:

- Thanked everyone who supported the West Seneca Cares project
- Referred to the salaries of the Supervisor, Town Clerk, and Highway Superintendent and stated all the salaries were cut by the former Supervisor after the election in 2019 and no prior notice was given to those elected; further, any time salaries are to be cut notice should be given to those people running for office. Supervisor Dickson stated they were aware of the salary cuts in October of 2019.
- Questioned the status of the Deer Task Force Councilmember Cantafio stated the December meeting
 was cancelled due to Covid, the task force is continuing to gather information and the members are
 working very hard. There is not an easy answer to the issue and there will be a presentation to the Town
 Board with their recommendations.
- Who will be in charge of the Burchfield Highway Superintendent Adams stated he will be overseeing
 the Burchfield. Supervisor Dickson stated the grant is in final review by the state and they expect the
 grant dispersal agreement soon. The resident asked if requests for donations for the Burchfield can be

added to the tax bills. Town Clerk Kobler stated that would be against the law.

A resident and representative of the Joint Veterans Committee had the following comments/guestions:

- Referred to the materials regarding the veterans' war monuments that was handed to the previous Town Attorney and questioned the whereabouts of the information – Supervisor Dickson stated he will discuss this with Mr. Trapp and anticipates a resolution.
- Bricks for Veterans are on sale until February 15, 2022.

A resident had the following questions:

- Referred to item No. 20 from the Reorganization Meeting and asked if Planning Board and Zoning Board positions are salaried positions and missed meetings result in no pay, are they now hourly positions as a salary covers the time one spends on all related tasks involved with the position. Does this open the town to discrimination or labor law issues Mr. Trapp stated discrimination under Department of Labor rules is more involved than how many absences occurred and depends on specific facts. The Town Board does have the discretion to withhold pay based on the circumstances of an absence and the Chair's recommendation. Councilmember Breidenstein stated the premise is if individuals are appointed to a paid position, just like unionized employees, they should report to work; this also provides oversight by the Town Board and holds the Chair and the committee members responsible for doing the work of the town. Supervisor Dickson stated this adds transparency to the process.
- Was the contract for the new grant writer reviewed by either the previous or new town attorney –
 Supervisor Dickson stated the contract was not reviewed by an attorney.
- Will the agreement with the new attorney be posted online, is it normal that it was not posted, and was it reviewed by an attorney -Supervisor Dickson stated yes, the agreement will be posted online, and it was reviewed by the Supervisor Dickson, Councilmembers Kims and Breidenstein, and Mr. Trapp; the entire Town Board had the contract prior to the meeting.
- Were any West Seneca firms or solo practitioners considered for Town Attorney Supervisor Dickson stated three prominent firms very active in municipal law were interviewed, there were no firms of their stature in West Seneca. Supervisor Dickson looked at solo practitioners two years ago and there are no new candidates.

A resident questioned why Adjusters International/BLC was not asked and/or allowed to submit a proposal after meeting with the Chief of Staff and asked for reconsideration by the Town Board – Chief of Staff, Amelia Greenan stated she did not have a formal meeting with the representative but did receive their information and passed it on to the Supervisor. Supervisor Dickson stated the two companies that were considered came to the Highway Garage, and both offered very qualified experience to select between.
