MARK HUMMEL - ENGINEERING DEPARTMENT

- Update on water main breaks at Mayer Bros. located at 1540 Seneca Creek Road; suggested replacing 1100' and two hydrants with an estimated cost of \$250,000
 - \checkmark Councilman Hart commented on 18-wheel trucks possibly causing the problem
 - ✓ Town Engineer Steven Tanner stated this was an area identified years ago by the water authority as needing inspection.
 - ✓ Councilman Hanley stated there have been repairs in the area and chlorine tests were completed approximately 150′ from the break, but the only place to have a test would be at the source. He suggested two 10″ water lines and services with Erie County who will be on the road at the same time.

TOWN ENGINEER STEVEN TANNER

- Update on proposed East & West Road sewer project \$480,000 for Phase I and \$520,000 for Phase II; Erie County plans to do Phase I road project next year and if sewer project is done in conjunction with the county project, the town will save the cost of sidewalks, asphalt & curb restoration
- Phase V & VI sewer lining Phase V is fully engineered and ready to go to bid and the sewer crew is about half way through the video for Phase VI. A grant for \$1.5 million was received from EFC with a zero interest loan on the remaining \$4.7 million balance.
- Update on library & community center project
 - \checkmark Furniture installation is beginning in the offices and library
 - \checkmark Final cleaning of the library space will be done before bringing the books over
 - ✓ Will be getting quotes on the purchase of plants for landscaping
 - ✓ Veterans bricks will be reinstalled
