- Ideal for newly elected officials and town board members
- Modules include: Conflict of Interest of Municipal Officers and Employees, Codes of Ethics and Other Local Actions, and Case Studies

## III. Draft of Onboarding, New Hires, Newly Elected Officials and Volunteers

- Would like to see new hires, newly elected officials and volunteers receive an employee handbook (which does not seem to currently exist), a copy of the Ethics Code and copy of the 'Whistle Blower Policy'
- One source (that requires an annual fee) will collect internal employee information
- Any external citizens can go right to the county, if there are any issues
- Need to finalize composition
  - Suggestions: Deputy Town Attorney, Town Attorney, Committee Chairperson, and Human Resources
  - Would not go any further unless they discovered there was an issue
- Disclosure Form Who would be required to complete?
  - All Elected Officials
  - Department Heads
  - Zoning Board of Appeals Members
  - Planning Board Members

- Ethics Board Members
- o Finance Department
- Deputy Town Attorney Jon Minear discussed the contractor disclosure forms for the town engineer
- What other boards to include?
  - Add the Environmental Commission
- Electrical Inspector and Code Enforcement Officers should fill out one of the disclosure forms
- Town Clerk Jacqueline Felser and Chairperson Amy Carpenter will put a list together of everyone who collects a paycheck
- Clerk Felser suggests ethics board reviews forms annually and the forms are to be then filed with the Town Clerk
  - Exact change "said forms shall be reviewed annually by the Ethics Board and then filed with the Town Clerk and HR"
- Does HR keep a file on Elected Officials? To be clarified. If not, board would like HR to have a file on elected officials.
- Include HR when presenting to the Town Board
- Oath book should be signed
- Include online annual harassment training (HR handles this)
- Ethics Board should also take training and possibly have a file where certificates of training completion are kept
