WHEREAS, as of December 31, 2018, the Highway Fund has available fund balance of \$308,488 which is not in nonspendable form or otherwise restricted; now, therefore, be it

RESOLVED, that pursuant to Section 6-c of General Municipal Law, as amended, there is hereby established a capital reserve to be known as the Capital Road Improvement Reserve (the "Reserve") in the amount of \$155,300. The purpose of this Reserve is to accumulate monies to finance the cost of future road improvement projects.

The chief fiscal officer is hereby directed to deposit and secure the moneys of this Reserve in the manner provided by Section 10 of General Municipal Law. The chief fiscal officer may invest the moneys in the Reserve in the manner provided by Section 11 of General Municipal Law and consistent with the investment policy of the town. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Reserve. The chief fiscal officer shall account for the Reserve in a manner that maintains the separate identity of the Reserve and shows the date and amount of each sum paid into the Reserve, interest earned by the Reserve, capital gains or losses resulting from the sale of investments of the Reserve, the amount and date of each withdrawal from the Reserve and the total assets of the Reserve, showing cash balance and a schedule of investments, and shall at the end of each fiscal year, render to the Board a detailed report of the operation and condition of the Reserve.

## **ISSUES OF THE PUBLIC**

- A Fisher Road resident requested that something be done with the intersection of Fisher Road and Langner Road in order to bring awareness to the intersection. Chief Denz responded these are county roads and they will have to work with Erie County to get something done. The Traffic Committee will get in touch with Erie County Legislator Joseph Lorigo and William Geary of Erie County DOT. The resident also requested a sign notifying drivers of the playground and requested enforcement of the stop sign. Supervisor Meegan responded the town can address the playground sign and Chief Denz stated the Police Department has patrolled that area in the past and will work with neighbors to make the area safer.
- A Fremont Avenue resident commented on the proposed car wash on Union Road stating he would like to see the process expedited as there are pesticides in the ground and loose asbestos on the property that needs to be cleaned up. Supervisor Meegan stated legally there is a process that has to be followed and Code Enforcement Officer Jeffrey Baksa stated the property owner needs a demolition permit to tear down the buildings. The resident stated the previous owner tore down the greenhouses last year and he questioned why no permits were obtained. Councilman Hanley stated unfortunately people do things without permission. Mr. Baksa stated the Code Enforcement Office tried to make the previous owner clean up the property and abide by the regulations. They cannot expedite the process or force the new project just to get the property cleaned up; the property should be cleaned up regardless of the project's approval. Councilman Hart stated if the new property owner does not clean up the property, the town will do the cleanup and put the cost on the tax bill.

# SEQRA RESOLUTION 2800 NORTH AMERICA DRIVE, WEST SENECA, NEW YORK

WHEREAS, the Town Board of the Town of West Seneca, as lead agency acting pursuant to the State Environmental Quality Review Act, Article 8 of the New York State Environmental Conservation Law, has reviewed Part I of the Short Environmental Assessment Form ("EAF") prepared by the applicant for property located at 2800 North America Drive ("Subject Property"), for construction of a onestory, 11,560 sf manufacturing/office facility and associated paved surface parking on 3.0 acres of vacant land (the "Project"), and reviewed the draft completed Part II of the EAF analyzing the potential for the Project to result in any significant adverse environmental impacts and has otherwise taken a hard look at the identified potential environmental impacts utilizing the criteria specified in 6 NYCRR 617.7(c); and

**WHEREAS,** upon review of Parts I and II of the EAF and documentation and plans submitted by the applicant in connection with the review of the Project, the Town Board has not identified any potentially significant adverse environmental impacts associated with the proposed use of the Subject Property, has determined that preparation of an Environmental Impact Statement is not necessary and that the issuance of a Negative Declaration is therefore appropriate; now, therefore, be it

**RESOLVED** that pursuant to 6 NYCRR 617.7(a) the Town Board does hereby adopt a Negative Declaration with respect to the Project based on its determination that the Project will not result in any potentially significant adverse environmental impacts.
