ISSUES OF THE PUBLIC

- A resident commented on the tax incentive plan for businesses and questioned if there is anything similar that could be made available to homeowners Councilman Hart explained the 485-b plan requires a business to expand their building or add value to the building in order to receive a tax credit. The credit can be over a ten year period and as high as 50 percent of the added value. Code Enforcement Officer Jeffrey Baksa commented Erie County has a low income loan program to help homeowners with repairs and Councilman Hart noted the program falls under the Community Development Program and only portions of the town qualify.
- A resident questioned if the Burchfield Center will be repaired Supervisor Meegan stated Code Enforcement Officer Jeffrey Schieber will be presenting the results of his investigation on the repairs at the July 15th work session, followed by a discussion on how to proceed. She further noted there is still outstanding litigation.
- A resident commented on the condition of Potters Road and questioned if the town could contact the county. Councilman Hanley responded he had reached out two weeks ago to Highway Sup't. Matthew English and he made the phone call right away. Crews were there filling pot holes and were also seen on Potters Road today.
- A resident commented on the following:
 - ✓ The recent vote for undocumented aliens obtaining driver's licenses and expressed appreciation of Senator Gallivan's "No" vote
 - ✓ Suggested a tax incentive for volunteer firemen to help attract members Supervisor Meegan advised there is a tax reduction received from New York State and Councilman Hart advised fire districts also participate in the Length of Service Award Program (LOSAP), a taxpayer funded retirement program for volunteer firemen. There is no local tax credit available for a Town Board to give a fireman.
 - ✓ Requested outgoing town officials leave their files for the incoming officials' use Supervisor Meegan responded the town is paperless; files are documented electronically
 and always retrievable.
