Town Attorney Tina Hawthorne advised the first page of the petition stated the anticipated cost to the residents for the project. The estimate is \$142,000 which would cost a homeowner \$250 annually for 15 years as well as a \$15 annual maintenance fee. Based on the resident's claims that this information was not disclosed when the petition was circulated, she recommended this item be tabled for further investigation.

Ken Hanson stated he circulated the petition and spoke with all the residents. He gave them the petition to read and some, including the resident who spoke, did not want to read it or did not want anything to do with it. Mr. Hanson noted that both streets were included on the recommendation of the town as it would be more cost effective.

Mrs. Hawthorne stated the Assessor's office validated the signatures that were submitted. The total assessed value of the entire district is approximately \$3.7 million; those that signed in favor of the lighting district represented \$2.3 million in assessed valuation and those opposed represented \$1.3 million in assessed valuation. Mrs. Hawthorne advised that approval is subject to a permissive referendum and could be put to a vote if a petition is filed in accordance with the timeframe prescribed by law.

Supervisor Meegan suggested Mr. Hanson go back to the residents and advise them of the cost per year.

Ethics Board member Theresa Funk gave the attached power point presentation outlining the additional proposed amendments to the Ethics Code since the August 12, 2019 public hearing. She further commented on what is involved in creating an independent ethics board going forward including selection of members, funding and enforcement of decisions.

Councilman Hanley questioned removal of a member by cause. Mrs. Funk stated that terms apply to members, but a member cannot be removed during their term without cause.

Chief Denz commented on the bargaining unit contracts and discipline procedures and questioned the possibility of a double jeopardy situation with regard to the proposal for additional discipline and financial penalties imposed by the Ethics Board.

Supervisor Meegan commented on the implementation of the original Code of Ethics and the resistance from the unions at that time. She suggested tabling this item until the areas of concern can be further examined.

Town Attorney Tina Hawthorne commented there is a potential for grievances being filed by the unions with regard to double jeopardy, 5th Amendment rights and violation of contracts. She would like the language to be reviewed in order to achieve the goals of this amendment without leaving the town in a vulnerable position.

Ethics Board Attorney Jon Minear stated the Ethics Board members had to investigate an ethics complaint earlier this year and did not have the power or ability to enforce their requests for the information they needed. Adding a financial sanction is one way to afford the board more compliance as its purpose is to make the government of the town more transparent by focusing on ethics code violations. He acknowledged the police have their disciplinary procedures and did not see double jeopardy as an issue. Mr. Minear further noted the Ethics Code is enforceable on all town employees.

A resident commented on Section L under Standards of Conduct and the addition of "no use of town property for political means," suggesting an exception be added to recognize that early voting takes place on town property.

WHEREAS, the Ethics Board determined that the Committee is a public entity established with the purpose of conducting meetings and deliberations open to the public; and

WHEREAS, the Ethics Board further determined that the Committee should be operating in an open and transparent manner as a part of the Town Government and not through a private, closed Facebook Group, which fails to include every member of the Committee and includes a non-member of the Committee who is currently a political candidate; now, therefore, be it

RESOLVED, the West Seneca Town Board accepts the recommendation of the Ethics Board that the Committee shall immediately cease communicating via their private, closed Facebook Group and shall shut down the private Facebook Group immediately. The Committee shall conduct all business in an open and transparent manner.

CODE REVISIONS BASED ON FEEDBACK

- Ethics Board presented proposed changes to Ethics code for the town
- Public feedback was documented
- Ethics Board reviewed comments and inserted additional changes based on the public feedback and experiences of the Board since the original presentation.

LEGISLATIVE INTENT



- Added a statement to clarify that the Ethics code is enforceable for all Town officials, officers and employees
- Also added a statement that regardless of acknowledgement or acceptance of the code, it remains enforceable.

DEFINITIONS/TERMS



- Updated existing definitions based on feedback
- Relative added grandparent and grandchild
- Recuse Revised to include not just abstaining but from also influencing in any official action

STANDARDS OF CONDUCT



- Section E gift value changed from \$75 to \$25 to coincide with NY State code
