# **PUBLIC COMMENTS ON COMMUNICATIONS**

A resident questioned/commented on the following:

- ✓ Will the position of Real Property Appraiser be filled Councilman Hanley confirmed the town is currently looking to fill the position. Supervisor Dickson stated the open position is for a Real Property Appraisal Technician with a lower salary of \$44,000; the total for both salaries will be an additional \$12,000. Elma has not reached a decision regarding sharing the service of Assessor; sharing could save the town approximately \$30,000 per year.
- ✓ Does Mr. Finbar have the appropriate certification to be Town Assessor Councilman Hanley confirmed Mr. Finbar is qualified through New York State for the position of Town Assessor
- ✓ Why the term of the Town Assessor is only until 2025 Town Attorney Tina Hawthorne stated the position is governed by NYS Real Property Tax Law and requires a term of 6 years; the current appointment is to fill the term that Ms. Wittmeyer retired from. Supervisor Dickson stated there are time constraints for appraisals to be completed in order for new assessments to be included on the tax roll.

  own contract; the school district piggybacks onto the town's contract and will
  reimburse the town. Supervisor Dickson stated Director of Finance Megan Wnek was
  not able to be in attendance at the meeting; Supervisor Dickson will follow up with her
  and report at the next Town Board meeting.
- ✓ Is Highway Laborer a new position Highway Sup't. Brian Adams stated two Highway Department employees retired in January and the positions are then filled through sanitation following the union agreement procedures
- ✓ No attachment to the Police Department Rules and Regulations item was included online – Chief Denz stated the policy has been in effect since 1968. Each new Town Board reviews the policy and may make suggestions; traditionally the policy is not viewable by the public and is a stricter scale concerning the administration, conduct and disciplinary standards of the Police Department.

# TOWN OF WEST SENECA, NEW YORK

### **INVESTMENT POLICY**

### **Updated February 2020**

# I. <u>SCOPE</u>

This investment policy applies to all moneys and other financial resources available for investment on behalf of the Town of West Seneca.

# II. OBJECTIVES

The primary objectives of the investment activities are, in priority order,

- to conform with all applicable federal, state and other legal requirements (legal);
- to adequately safeguard principal (safety);
- to provide sufficient liquidity to meet all operating requirements (liquidity); and
- to obtain a reasonable rate of return (yield).

# III. DELEGATION OF AUTHORITY

The Town Board's responsibility for administration of the investment program is delegated to the Town Supervisor and Director of Finance who shall establish written procedures for the operation of the investment program consistent with these investment guidelines. Such procedures shall include an adequate internal control structure to provide a satisfactory level of accountability based on a data base or records incorporating description and amounts of investments, transaction dates, and other relevant information and regulate the activities of subordinate employees.

### IV. PRUDENCE

All participants in the investment process shall seek to act responsibly as custodians of the public trust and shall avoid any transaction that might impair public confidence in the Town of West Seneca to govern effectively.

Investments shall be made with judgment and care, under circumstances then prevailing, which persons of prudence discretion and intelligence exercise in the management of their own affairs, not for speculation, but for investment, considering the safety of the principal as well as the probable income to be derived.

All participants involved in the investment process shall refrain from personal business activity that could conflict with proper execution of the investment program, or which could impair their ability to make impartial investment decisions.

### V. DIVERSIFICATION

It is the policy of the Town of West Seneca to diversify its deposits and investments by financial institution, by investment instrument, and by maturity scheduling.

### VI. <u>INTERNAL CONTROLS</u>

It is the policy of the Town of West Seneca for all moneys collected by any officer or employee of the Town to deposit those funds in the designated Town bank account; of less than \$1,000.00 within five business days of receipt, or \$1,000.00 or more within two business days of receipt, or within the time period specified in law, whichever is shorter.

The Supervisor and Director of Finance are responsible for establishing and maintaining an internal control structure to provide reasonable, but not absolute, assurance that deposits and investments are safeguarded against loss from unauthorized use or disposition, that transactions are executed in accordance with management's authorization and recorded properly, and are managed in compliance with applicable laws and regulations.

### VII. DESIGNATION OF DEPOSITORIES

The banks and trust companies authorized for the deposit of monies will be (re)authorized annually at the Town Board's annual (re)organizational meeting.

### VIII. COLLATERALIZING OF DEPOSITS

In accordance with the provisions of General Municipal Law, Section 10, all deposits of the Town of West Seneca, including certificates of deposit and special time deposits, in excess of the amount insured under the provisions of the Federal Deposit Insurance Act shall be secured:

- 1. By a pledge of "eligible securities" with an aggregate "market value" as provided by GML Section 10, equal to the aggregate amount of deposits from the categories designated below:
  - a) Obligations issued, or fully insured or guaranteed as to the payment of principal and interest, by the United States of America, an agency thereof or a United States government sponsored corporation.
  - b) Obligations issued or fully insured or guaranteed by the State of New York, obligations issued by a municipal corporation, school district or district corporation of such State or obligations of any public benefit corporation which under a specific State statute may be accepted as security for deposit of public moneys.

# IX. SAFEKEEPING AND COLLATERALIZATION

Eligible securities used for collateralizing deposits shall be held by the depository and/or a third party bank or trust company subject to security and custodial agreements.

The security agreement shall provide that eligible securities are being pledged to secure local government deposits together with agreed upon interest, if any, and any costs or expenses arising out of the collection of such deposits upon default. It shall also provide the conditions under which the securities may be sold, presented for payment, substituted or released and the events which will enable the local government to exercise its rights against the pledged securities. In the event that the securities are not registered or inscribed in the name of the local government, such securities shall be delivered in a form suitable for transfer or with an assignment in blank to the Town of West Seneca or its custodial bank.

The custodial agreement shall provide that securities held by the bank or trust company, or agent of and custodian for, the local government, will be kept separate and apart from the general assets of the custodial bank or trust company and will not, in any circumstances, be commingled with or become part of the backing for any other deposit or other liabilities. The agreement should also describe that the custodian shall confirm the receipt, substitution or release of the securities. The agreement shall provide for the frequency of revaluation of eligible securities and for the substitution of securities when a change in the rating of a security may cause ineligibility. Such agreement shall include all provisions necessary to provide the local government a perfected interest in the securities.

# X. PERMITTED INVESTMENTS

As authorized by General Municipal Law, Section 11, the Town of West Seneca authorizes the Supervisor and the Director of Finance to invest moneys not required for immediate expenditure for terms not to exceed its projected cash flow needs in the following types of investments:

- Special time deposit accounts;
- Certificates of deposit;
- Obligations of the United States of America;
- Obligations guaranteed by agencies of the United States of America where the payment of principal and interest are guaranteed by the United States of America;
- Obligations of the State of New York;

All investment obligations shall be payable or redeemable at the option of the Town of West Seneca within such times as the proceeds will be needed to meet expenditures for purposes for which the moneys were provided and, in the case of obligations purchased with the proceeds of bonds or notes, shall be payable or redeemable at the option of the Town of West Seneca within two years of the date of purchase.

## XI. AUTHORIZED FINANCIAL INSTITUTIONS AND DEALERS

The Town of West Seneca shall maintain a list of financial institutions and dealers approved for investment purposes and establish appropriate limits to the amount of investments which can be made with each financial institution or dealer. All financial institutions with which the local government conducts business must be credit worthy. Banks shall provide their most recent Consolidated Report of Condition (Call Report) at the request of the Town of West Seneca. Security dealers not affiliated with a bank shall be required to be classified as reporting dealers affiliated with the New York Federal Reserve Bank, as primary dealers. The Supervisor and Director of Finance are responsible for evaluating the financial position and maintaining a listing of proposed depositories, trading partners and custodians. Such listing shall be evaluated at least annually.

# XII. PURCHASE OF INVESTMENTS

The Supervisor is authorized to contract for the purchase of investments:

- 1. Directly, including through a repurchase agreement, from an authorized trading partner.
- 2. By participation in a cooperative investment program with another authorized governmental entity pursuant to Article 5G of the General Municipal Law where such program meets all the requirements set forth in the Office of the State Comptroller Opinion No. 88-46, and the specific program has been authorized by the governing board.
- 3. By utilizing an ongoing investment program with an authorized trading partner pursuant to a contract authorized by the governing board.

All purchased obligations, unless registered or inscribed in the name of the local government, shall be purchased through, delivered to and held in the custody of a bank or trust company. Such obligations shall be purchased, sold or presented for redemption or payment by such bank or trust company only in accordance with prior written authorization from the officer authorized to make the investment. All such transactions shall be confirmed in writing to the Town of West Seneca by the bank or trust company. Any obligation held in the custody of a bank or trust company shall be held pursuant to a written custodial agreement as described in General Municipal Law, Section 10.

The custodial agreement shall provide that securities held by the bank or trust company, as agent of and custodian for, the local government, will be kept separate and apart from the general assets of the custodial bank or trust company and will not, in any circumstances, be commingled with or become part of the backing for any other deposit or other liabilities. The agreement shall describe how the custodian shall confirm the receipt and release of the securities. Such agreement

shall include all provisions necessary to provide the local government a perfected interest in the securities.

# XIII. REPURCHASE AGREEMENTS

Repurchase agreements are authorized subject to the following restrictions:

- All repurchase agreements must be entered into subject to a Master Repurchase Agreement.
- Trading partners are limited to banks or trust companies authorized to do business in New York State and primary reporting dealers.
- Obligations shall be limited to obligations of the United States of America and obligations guaranteed by agencies of the United States of America.
- No substitution of securities will be allowed without the knowledge/agreement of the Town of West Seneca.
- The custodian shall be a party other than the trading partner.
