Motion by Supervisor Dickson, seconded by Councilman Bauer, to approve Minutes #2020-07 of March 30, 2020.

On the question, Councilman Hanley stated the minutes were fine; however, the words that were never said at the meeting are the reason for his agenda item. The email comments to the Town Board that never made the meeting.

Supervisor Dickson stated that it was the first online meeting and comments were sent to Brendon Najm and then forwarded to the Town Board members.

Councilman Hanley stated he did not receive emails from Mr. Najm.

Supervisor Dickson replied the emails were sent to Mr. Najm's work email and asked if the other Town Board members received that email from him.

Councilman Piekarec stated he did receive an email from Mr. Najm a few hours before the meeting and one just prior to the meeting.

Councilman Hanley stated he received "cliff notes" but not the emails.

Supervisor Dickson questioned the Town Clerk about the emails being included with the meeting minutes.

Town Clerk Kobler stated there were fourteen additional emails sent to the Town Board that were never read or acknowledged at the previous meeting. After consulting with the New York State Committee on Open Government about the discrepancy involving the emails received by the different parties; based on their guidance the emails will not be included with the meeting minutes but will be on file in the Town Clerk's office.

On the question, Supervisor Dickson stated the Governor has allowed Public Hearings to be held online and he would like to do this at the next Town Board meeting.

Town Attorney Hawthorne stated this is correct; it is also an option to hold off until June 1, 2020, without prejudice. Ms. Hawthorne advised Town Clerk Kobler to contact the two parties and see if they would like to proceed at the next meeting or wait until June 1st. If they would like to proceed, the Town Clerk will send notification letters to property owners in the surrounding areas. Town Attorney Hawthorne advised that the parties receiving notification will need to indicate how they can be contacted to be part of the public hearing.

Supervisor Dickson suggested having all written comments be sent to the Town Clerk and if the parties would like to speak they will receive an invitation to join the video conference. Town Attorney Hawthorne agreed that written communications would be directed to the Town Clerk and requests to speak during the meeting would be forwarded to the Supervisor's Office.

A resident stated three board members had not responded to an email sent after the last meeting, while the Supervisor and one other had. The three board members mentioned: Mr. Cantafio, Mr. Bauer, and Mr. Hanley stated they were not in receipt of an email from the person and will respond when it is received through their town email accounts.

 Councilman Hanley re Board Meeting Correspondence procedure Motion by Councilman Hanley, seconded by Supervisor Dickson, to adopt the following resolution regarding Board Meeting Correspondence Procedure:

WHEREAS, the Town Board is duly elected to represent all residents of the Town of West Seneca and,

WHEREAS, the Town Clerk is duly elected to perform several duties for the Town of West Seneca, including serving as Secretary to the Town Board; and,

WHEREAS, the meeting of the Town Board on March 30, 2020, was held virtually in accordance with Executive Order 202.1; and,

WHEREAS, due to the public not being able to speak at the meeting, correspondence for the agenda items of said meeting was requested and received by the Supervisors office; and,

WHEREAS, all members of the public deserve equal opportunity to have their voices heard; and,

WHEREAS, a Town Board may adopt procedural rules which would authorize the Supervisor to retain the original correspondence received, and file copies of such with the Town Clerk.

NOW, THEREFORE, be it resolved that the Town Board hereby adopts the procedure that all correspondence from the public relative to Town Board meetings, requested by the Town Board, be received by the Town Clerk's Office; and,

BE IT FURTHER resolved, that any public correspondence received by a member of the Town Board regarding an issue before the Town Board shall be submitted to the Town Clerk as Secretary to the Town Board prior to the occurrence of the next Town Board meeting; and,

BE IT FURTHER resolved, that the Town Clerk shall distribute such correspondence in a timely manner respectful to Town Board members prior to the occurrence of the next Town Board meeting.

On the question, Supervisor Dickson requested clarification on the phrase "public correspondence" as opposed to "correspondence."

Councilman Hanley stated this resolution is specifically related to the last meeting in regards to the discussion on the Burchfield Center. The emails against the resolution were put into public record, yet the emails received in favor were never mentioned; anything that's related to Town Board Meetings should go through the Clerk's office.

Supervisor Dickson reiterated the direction given to the public before that meeting was communications should be sent to Mr. Najm; but he understands the point being made. Supervisor Dickson asked for clarification of the word "shall be submitted"; is the intended meaning that any correspondence about an issue before the Town Board "must" be submitted or "may" be submitted.

Councilman Hanley stated the intention is to avoid another occurrence like the Burchfield when a controversial topic is before the Town Board; that positive and negative comments are represented.

Supervisor Dickson further stated his interpretation of "shall" would mean all emails about any Town Board matter, including personal opinions about Town Board members, would need to be forwarded. Supervisor Dickson would like Town Board members to be able to use their discretion.

Town Attorney Hawthorne believed the intent was any correspondence of the public – meaning coming from the residents.

Councilman Hanley responded that is correct; he is not referring to everyday emails but specifically correspondence from the public related to an agenda item.

Town Attorney Hawthorne stated concerns in regards with a Town Board member making a discretionary decision about forwarding the email to the Town Clerk, the person's email would need to specify whether they intend to make the comment public.

Councilman Hanley stated all emails can be FOILed.

Town Attorney Hawthorne agreed yet private citizens may want to reach out to a Town Board member and not want to make a public comment; that person's email would have to specify they do not wish the email to be made public.

Councilman Cantafio stated he believes the focus is on making sure that everyone has a voice and that all comments are heard and supports the resolution because what the Town Clerk receives is on record, and it's at her discretion what to include in the minutes. Councilman Cantafio would like to leave that at the discretion of the Clerk as she is following the recommendation of New York State Committee on Open Government and would like the process centralized with the Clerk. Councilman Cantafio noted the majority of people he has spoken to have called him and phone calls should not be overlooked as some residents are not able to email or participate on Facebook. Additionally, the Facebook page itself should be looked at. Councilman Cantafio questioned the discretion of who decides what is stated and what isn't during the online meetings, pointing out Mr. Najm is controlling what is read from Facebook.

Councilman Piekarec suggested establishing a general phone line with voicemail for the entire Town Board and a general email account that all Town Board members and the Town Clerk have access to.

Supervisor Dickson mentioned the "Contact Us" button on the town website and agrees that all correspondence should go through one contact. All council members have the ability to speak up about any communications they have received.

Councilman Cantafio questioned if a Town Board member makes a motion to submit something, it's seconded, and voted on to become part of the record, would this be part of the record. Town Attorney Hawthorne confirmed that would be correct. Comments received by the Town Clerk would be made public, and additional items received by a Town Board member can be brought to attention by way of motion instead of forwarding it to the Town Clerk.

Supervisor Dickson agrees with this process and stated the resolution isn't necessary.

Councilman Hanley stated he changed the word "shall" to "to": regarding an issue before the Town Board to be submitted to the Town Clerk.

Town Attorney Hawthorne stated it is the same thing and asked if that is still an obligation of a Town Board member to forward a communication to the Town Clerk. Councilman Hanley stated that is correct.

Town Attorney Hawthorne questioned if this was to apply only for online meetings or all meetings going forward. Councilman Hanley responded all meetings going forward. Supervisor Dickson and Councilman Bauer were in agreement.

Supervisor Dickson questioned if there was an amendment made.

Town Attorney Hawthorne questioned if the all changes include the following: any correspondence of the public received by a member of the Town Board related to an agenda item before the Town Board to be submitted to the Town Clerk as Secretary to the Town Board prior to the occurrence of the next Town Board meeting.

Supervisor Dickson suggested using "may" be submitted.

Councilman Cantafio reiterated the points of the Resolution to be: having a centralized place for comments to be received – the Town Clerk, the ability for comments to be recognized during meetings by any Town Board member, the Secretary to the Town Board will use discretion for the minutes, and the Town Board will have the authority to vote in items to the minutes, thus eliminating one person from having ultimate authority over the contents of the minutes.

Councilman Hanley agreed and read a revised iteration: Be It further resolved that any public correspondence received by a member of the Town Board related to a Town Board issue is to be submitted to the Town Clerk as Secretary to the Town Board.

Town Attorney Hawthorne asked for clarification if there could be "Town Board issues" that are not on the agenda.

Councilman Hanley stated the intention is just for agenda items: "related to an agenda item before the Town Board."

Councilman Cantafio would like phone calls recognized as well; he received multiple phone calls. During the time of online meetings, besides an email, they may call Town Board members or the Town Clerk; some of our residents are not on the internet.

Supervisor Dickson commented that many more comments are being received through Facebook than were received in previous meetings. Another concern would be that there's no intention the Town Board is requiring everyone to send in communications to the Town Clerk.

Councilman Piekarec questioned if multiple copies of the same email received by multiple Town Board members will be put in the record.

Supervisor Dickson responded that one copy would be included. The point isn't to get a complete transcript of every single person it is to get more of a flavor of the public that chose to express an opinion.

Town Clerk Kobler stated her understanding is that all the emails would be received by her office and would be forwarded to the Town Board. In the minutes, for example, we received an email regarding Item No. 2, etc; not necessarily attaching the email to the minutes. The point is to make everyone aware that there are different opinions.

Councilman Piekarec asked if it should state only written correspondence as he received many phone calls, also. How would phone calls be tracked? Town Clerk Kobler replied phone calls can also be directed to the Town Clerk's Office. Town Attorney Hawthorne responded the word correspondence in general includes a letter, an email and phone call.

Councilman Cantafio stated while we cannot have an open meeting we are trying to find the best way to have people heard and expressed his appreciation of the work everyone is doing to continue to stream line the process.

Supervisor Dickson again questioned if the Resolution is necessary.

Councilman Hanley stated he will request to table the item to be able to revise it.

Motion by Councilman Hanley, seconded by Supervisor Dickson, to table this item to allow Councilman Hanley to revise and resubmit for the next Town Board Meeting.






