AGREEMENT

This Agreement is by and between the Town of West Seneca, a New York State Municipal Corporation with offices located at 1250 Union Road, West Seneca, New York (the "Town"), and the Buffalo Niagara Sports Commission (the "BNSC") with offices located at 403 Main Street, Suite 630, Buffalo, New York 14203 (collectively, the "Parties").

WITNESSETH

WHEREAS, the Town owns and maintains certain recreation facilities; and

WHEREAS, the BNSC has been working with the National Softball Association, Inc. (the "NSA") to locate appropriate facilities to host an event within the Buffalo Niagara Region; and

WHEREAS, the Town has been selected by the NSA as a host for the 2018 NSA Class B North Eastern Softball Fastpitch World Series from July 21, 2018 to July 29, 2018; and

WHEREAS, the NSA will be using certain Town recreation facilities and such use will result in overtime costs to the Town; and

WHEREAS, the Town provides relief to its taxpayers by passing overtime costs associated with use of the recreation facilities to the user; and

NOW THEREFORE, and in mutual consideration thereof, the Parties hereby agree as follows:

1. BNSC hereby agrees to furnish the Town with payment for actual overtime costs incurred by the Town which relate to maintaining the recreation facilities used by the NSA during the 2018 NSA Class B North Eastern Softball Fastpitch World Series.
