Bids were opened on August 27, 2020 for the above referenced project. A copy of the bid tabulation is enclosed for your information and review. The low bidder was Sicoli Construction headquartered in Niagara Falls, NY with a bid amount of \$105,400. There was a total of 6 bidders on this project with bids ranging from \$105,400 to \$194,411. All bids were over the engineers estimate of \$80,000 for this project.

Given there were quite a few bids that were close in amount at the lower range of bids, we feel that the bid is an accurate representation of the work shown on the drawings.

We have reviewed Sicoli's bid with them and have checked some of their references. We are comfortable with their bid and ability to perform the work. Should the board elect to award this work, the Town Board should pass a resolution "Accepting the Bid received from Sicoli Construction for the Veterans Park Pavilion Rehabilitation in the amount of \$105,400 and authorize the supervisor to sign agreements and paperwork to enter into a construction contract".
