Spray Pad Bid Opening - Award of Contract

Honorable Board Members,

The Spray Pad construction project bid opening was on February 11, 2021 at 2:00pm in the West Seneca Community Center Community Room. A total of 5 bids were received for this project as indicated in the attached bidder checklist. The project will deconstruct the small wading pool area at the existing Town Pool property and turn it into a spray park. A new water service will be installed for this project to service just the spray pad. A portion of the demolition work and the supply and hauling of stone materials will be performed by the Town of West Seneca Highway Department.

The low bidder on this project for both alternatives is Gardenville Landscape and Nursery, LLC. They are located on Clinton Street in West Seneca. CPL does not have any experience working with Gardenville. Upon request, they provided me with a list of 6 references for similar projects. I spoke with the project managers on 4 of these projects all of whom made positive recommendations for the work completed, which ranged from Playground Installations to Pool Complex repurposing. We also spoke with the owner of Gardenville Landscape and Nursery, David Schwalenberg and he had a full understanding of the bid documents and the requirements of the project. His prices were \$208,000 for bid alternate A, which includes 17 spray features, 3 of which are structures and \$298,000 for bid Alternate B, which includes 23 spray features, 9 of which are structures.

Upon your review, please let me know if you have resolved to award this project and if so, which alternative you would like to move forward with. In order to keep on schedule and have the spray pad operational by July 1, 2021, the project would need to be awarded at your February 22, 2021 board meeting.
