



Summer Day Camp registration begins 3/1/2021 and Swim Lesson Levels and Little Swimmers registration is now open. These programs and facilities opening/running will be contingent upon the following factors (a) staffing levels. Appointments will be scheduled Monday Friday during our regular hours of operation when times are available. The department resuming its regular hours of operation for walk in membership cards and program registration is contingent upon staffing levels. We are now hiring CLERK TYPIST PT. - Open Public Skate, Adult Skate and Over 30 As of 1-15-2021 NYSDOH/ECDOH was not allowing programs such as Adult Skate and Open Public Skate. Hockey is only permitted to practice. Games and scrimmages are not allowed (this includes both organized leagues and pick up). Adult Skate, Open Skate and Over 30 ends annually in late March. If/When NYS allows these programs the department will not have enough time between the date the programs are allowed again, to complete the hiring, on boarding, orientation, and training process to run a season. Therefore, Adult Skate, Open Public Skate and Over 30 Hockey have been cancelled for the 2021 season as of 1-15-2021.
- CCL Youth Gym Programs have been suspended due to COVID-19 and low staffing levels. programs re-starting is contingent upon proper staffing levels. We are still collecting employment applications for these programs. Please see our website for more information regarding open jobs.
