The Town of West Seneca is issuing a Request for Proposals (RFP) for a 60-month lease of a Wide Format Multifunctional Plotter Scanner Printer.

The Town of West Seneca's Engineering Department intends to lease one (1) new Wide Format Multifunctional Plotter Scanner Printer. The awarded firm will be expected to supply, deliver, set-up and install the imaging system equipment so it is ready for production use, including all necessary communication, power cables and memory. And additionally interfacing with the Town's IT contractor for network connectivity set-up and configuration.

Proposed equipment shall meet the following specifications:

- Print/ scan/ copy functionality
- Networked device
- · Color and monochrome printing and scanning
- 2 roll paper capacity
- 11" to 36" output width
- 600 x 2400 dpi print resolution
- 6D PPM / 360 D size prints per hour

- The existing equipment will be removed by Town employees prior to delivery of the new equipment.

Insurance:

The successful proposer will agree to indemnify and hold the Town of West Seneca, its board members and employees harmless against all lost, cost, or damage, on account of injury to person or damage to property as a result of any action or inaction of the successful proposer or its representatives or agents or subconsultants in performance of this contract and against all fines, penalties or any other losses which the Town shall be obliged to pay or incur in connection with the performance of this work under the contact.

The successful proposer shall procure and maintain at his/her own expense and without expense to the Town, insurance for liability for damages imposed by law, of the kinds and amounts hereinafter provided, in insurance companies authorized to do business in the State of New York cover all operations under the contract whether performed by the successful professional or his/her subconsultants. Before the inception of this contract, the successful professional shall furnish to the Town a certificate of insurance form satisfactory to the Town exhibiting compliance with this paragraph and providing that the policies shall not be changed or cancelled until thirty (30) days written notice has been given to the Town. The types and limits of insurance shall be as follows

- a) Workers Compensation as required by law
- b) Disability benefits as required by law
- c) Bodily Injury liability \$1,000,000 each occurrence, \$3,000,000 aggregate
