ISSUES OF THE PUBLIC

Residents questioned/commented on the following:

✓ Speeding on Covington Drive has been and continues to be a problem, reminding the Town Board a petition with 103 signatures requesting the speed limit be lowered to under 35mph, possibly to 25mph and further asks the Town Board to put this in writing to the state − Supervisor Dickson has been in contact with a NYS Traffic Engineer about the process that recommends enforcement of the limit versus the lowering of the speed limit. Councilman Hanley commented that a previous effort by the police to enforce the limit resulted in several residents from Covington Drive, Tudor Boulevard, and Tampa Drive

being cited for speeding. Supervisor Dickson questioned if the Traffic Safety Committee reviewed this situation. Highway Superintendent Adams stated digital speed signs were placed on the road for a period of one week and only a few cars were recorded over the speed limit; additionally, extra police patrols were assigned. Chief Denz stated the high speeds captured were intermittent throughout the day compared to the below average speeds recorded overall. Further, placing temporary speed bumps has been considered and patrols do make their rounds; there is no easy solution. The resident questioned if a stop sign could be placed on the street. Highway Superintendent Adams stated this option can be investigated. Supervisor Dickson questioned if speed cameras were an option. Chief Denz stated the department does not possess any cameras.

✓ How is JCL Telecommunications providing telephone numbers, telephone lines, and 911 service − Supervisor Dickson stated the service for the town is being added to the police network and he has been reassured those components are covered. Chief Denz stated the 911 system is already in place and supplemental lines are being added.
