Subject: Abandonment of Paper Streets

Julius Place and Janice Place

Grant Boulevard

Pursuant to §205 of the New York State Highway Law, a highway is deemed abandoned if it is not open and working within six (6) years from the time it is laid out.

Kindly adopt the attached Resolutions authorizing the Town Board and the Superintendent of Highways to sign Statements of Abandonment in a form approved by this office declaring the Town's abandonment of Julius/Janice Place and Grant Boulevard as set forth in the Schedule A of the Statements of Abandonment.

These paper roads are being abandoned as part of the development of the Queens Landing Subdivision.



### Resolution for Abandonment of Julius Place and Janice Place
