

Arrival and Departure Procedure (Change) Drop Off:

Parents and/or Guardians are required to walk their camper in for the day and pick them up for the day. Parents/Guardians cannot leave until any required prescreening is completed. Campers will not be admitted in for the day without a parent or guardian. All campers are required to be signed in on the attendance sheet within the Ice Rink lobby when they arrive by their parent or guardian.

A staff member may screen your camper by checking for required items before the camper is admitted into the program. If your camper does not pass the screening and/or does not have the required items he/she will be sent home for the day (no refund will be issued).

Your child needs to arrive at camp no later than 9:00 AM daily to ensure they do not miss out on field trips and other activities. In the event of late arrival, the child may not be admitted into camp that day. A refund will not be issued.

Campers will not be admitted into the program if they arrive without sneakers on their feet, a water bottle (separate drink from their lunch drink), and a lunch.

Absences from camp must be called in to (716)674-6086 before 9:00 A.M. Please leave a voicemail, if there is no answer. You can also email absences by 9:00 AM to Imasset@twsny.org.

The drop-off policy could change at any time, with no notice or warning.

Pick Up:

Parents/Guardians are required to enter the Ice Rink and pick up their camper for the day. All campers must be signed out by a parent or an authorized person designated on the camper's registration form. If someone else must pick up your child or if your child is going home with an older sibling, you must send in a written note ahead of time notifying the Camp Program Director or they must be listed at the time of registration. Phone calls are not acceptable. Our staff will require identification from anyone picking up your child whom they do not recognize. Our staff reserve the right to not release the camper to any person who does not have proper ID and/or is not listed as an approved pick up on the registration form (regardless if a note was sent in).

Post-Camp Supervision runs 4:00 – 5:30 PM. Parents/Guardians of the enrolled child will be charged \$2.00 per minute per family after 5:30 PM. If a parent has not shown up by 5:30 PM Town of West Seneca staff will attempt to contact the campers Emergency Contacts for pick up. If we cannot reach any of the contacts by 5:40 PM and/or the child is not picked up by 6:00 PM the West Seneca Police will be contacted. Payment of fees for late pick up must be made no later than the next morning in full or the camper(s) will not be permitted to stay at camp until fees are paid. If a child is picked up late more than three (3) times in a season the child may be ejected from the camp program with no refund. There are no exceptions to this policy. Campers must be picked up on time.

The pickup policy could change at any time, with no notice or warning.

Mask Policy

- Staff are required to wear face coverings at all times, even if fully vaccinated, to model wearing a face covering when with children/campers at times when children/campers must wear face coverings.
- Staff who are fully vaccinated (for two weeks) and have a copy of their COVID-19 vaccine card on file with the department, can remove their face coverings when outside and at least 15 feet away from campers and not engaging in any camp activities (i.e., on break, before/after shift, etc.).
- Veterans Park Complex is considered an outdoor public space. Therefore, campers will be required to wear a face-covering at all times unless they are socially distanced 6 ft. apart from one another, eating, drinking, showering, or participating in water activities/play.
- Campers must wear masks at all times when inside unless they are socially distanced 6 ft. apart from
 one another. This includes restrooms with multiple stalls.
- Campers will be given mask breaks when indoors and outdoors throughout the day.
- Campers should bring a second face covering with them, in the event theirs becomes soiled, damp, etc., throughout the day.
- Acceptable face coverings for COVID-19 include but are not limited to cloth-based 2-ply face coverings and disposable masks that securely cover both the mouth and nose (bandanas, buffs and face shields are not acceptable face coverings).
- If your camper cannot tolerate a face covering, you must provide a doctor's note which states the campers name, the reason they cannot tolerate the face covering, and the dates to/from that they cannot tolerate the face covering. This note must be submitted to lmasset@twsny.org a minimum of one week before the camper attends the program.
- The mask policy could change at any time, with no notice or warning.

COVID-19 Symptoms Policy

Parents/Guardians must pre-screen their campers for signs/symptoms of COVID-19 each day within one hour prior to dropping your camper off. Parents/Guardians must ensure that their camper can answer NO to each question below prior to sending their camper to camp each day. If the answer is YES to any question below, you must keep your camper home.

- 1. Has your camper knowingly been in close or proximate contact in the past 10 days with anyone who has tested positive through a diagnostic test for COVID-19?
- 2. Has your camper or anyone in the camper's household tested positive through a diagnostic test for COVID-19 or had inconclusive test results in the past 10 days?
- 3. Does your camper or anyone in the camper's household have pending diagnostic test results for COVID-19?
- 4. Has your camper experienced any symptoms of COVID-19, including, but not limited to, a temperature of greater than 100.0 F (degrees) in the past 14 days? If your camper is not fever-free, without the assistance of medicine for 48 hours, your camper cannot attend camp.
- 5. Has your camper traveled internationally or for a period of 24 hours or more within another State (other than Connecticut, Massachusetts, New Jersey, Pennsylvania, or Vermont) in the past 14 days?

There will be no refunds for non-attendance related to COVID-19. The requirement that parents/guardians must conduct a pre-screen will be strictly enforced. If we determine there has been a failure to abide by the pre-screen requirements, a camper and all other campers in the same household may be asked to leave the camp for the remainder of the 2022 camp season and may not be eligible to register for camp in 2023.

The Town of West Seneca reserves the right to pre-screen any camper at the time of drop off with the above questions, additional questions, symptom check, and/or temperature check.

If a camper is sent home and/or not admitted into the program for a temperature over 99°, experiencing signs/symptoms of COVID, positive screening answers, or otherwise based on concerns related to COVID signs/symptoms, they will not be permitted to return to the program until they can (a) provide a negative COVID-19 test; (b) provide a doctor's note with an alternative diagnosis (note must state the camper can return to camp and must also state what is causing the symptoms); or (c) does not attend the program for 10 days. Refunds will not be issued in these cases.

Camp Overview

Welcome to the Town of West Seneca's Summer Day Camp Program. We are so excited to have the opportunity to offer such a great service to the families of West Seneca.

It is our goal to make Summer Camp a safe and memorable experience for all campers. Ensuring the safety of all campers is our number one priority. Our staff is trained in CPR/First Aid, child abuse awareness training and has had experience working with children. Our counselor-to-camper ratio exceeds the minimum requirements stated by the Eric County Health Department. Your child will be always supervised, and we ensure you that they will be well taken care of. The daily Camp schedule will be filled with a wealth of engaging activities that will be both fun and educational

Please read the following information (with your camper) regarding our Summer Camp. We want all parents to be well informed, to have their children prepared for Camp, and know what to expect.

Camp Overview

The Town of West Seneca Youth & Recreation Summer Day Camp Program runs for five weeks for children ages 6-10. Camp will be held at Veteran's Memorial Park located at 1250 Union Road in West Seneca. The main drop off and pick-up point will be at the Town Ice Rink located behind Town Hall. The Camp's daily activities will be spread throughout the park.

The Summer Camp's hours will be Monday-Friday from 9:00 AM until 4:00 PM. We are offering additional morning and afternoon supervision that begins at 7:30 AM and the post Camp supervision ends at 5:30 PM. This additional service is complimentary, will be structured and well supervised. This service will give parents the opportunity to drop off their child before work and then pick them up at the end of their day.

Campers will be placed in groups according to their age. Each group will be assigned a Camp Counselor and an Assistant Camp Counselor who will lead them through their daily age appropriate activities.

New York State Department of Health (and ECDOH)

In New York State, when a children's program qualifies as a camp, it must have a state, city, or county health department permit to operate legally and must operate in compliance with <u>Subpart 7-2</u> of the State Sanitary Code requirements. A permit is issued only when the camp follows the state's health

Children's camps must be inspected twice yearly by a health department representative. At least one inspection must be made during the time the camp is in operation. Each camp is checked to make sure that the physical facilities are safe and that supervision is dequate.

Not all summer programs for children qualify as children's camps. Parents are encouraged to ask the camp director if the camp has a permit from their local health department. Gontact the local health department having jurisdiction in the city or county that the camp is located, if you have questions.

New York State Sanitary Code Subpart 7-1, Children's Camps, requires that children's camp operators develop, review annually, update and implement a written safety plan. This plan must be submitted to the <u>total Health Department</u> (LHD) or State District Office that has jurisdiction in the county or city where the camp is located for their review and approval. The plan must accurately describe the camp's procedures for personnel, facility operation and maintenance, lire safety, medical, general and activity safety, staff training, and camper orientation. The Town of West Seneca approved safety plan can be found on our website after it has been approved.

The Town of West Seneca is required to follow all state and county health department rules and regulations in order to operate our Summer Day Camp Program. More information: https://www.health.mv.gov/environmental/outdoors/camps/

By enrolling your camper in the program you automatically agree to understand and follow all procedures as outlined in NYS Sanitary Code Subpart 7-2, the camp Safety Plan and this Parent Handbook.

Registration/Refund Policy

SPACE IS LIMITED, SPOTS ARE ON A FIRST COME FIRST SERVE BASIS.

REGISTRATION CLOSES WHEN ALL SPOTS ARE FILLED OR ON JUNE 1, 2022 whichever comes first.

Campers are informed of the rules and expectations, given a tour of the facility, field trip expectations, special activities, a review of possible site hazards and a fire drill will take place within the first 48 hours. Campers who are not present on the first day that they attend.

Camp Attire

The Summer Day Camp is a highly active outdoor program. Please send your child to camp in the blue camp shirt they were provided (or a similar light blue shirt), shorts, socks, and sneakers. Please be advised that the compet and their clothes may get dirty and wet during the camp day. We understand that it may be difficult to have the camp shirt washed every day. Camp shirts are required on off-site field trip days but campers can wear them on other camp days. In 2022 there will be no off-site field trip days in the event your child is not able to wear their camp shirt that day a light blue t-shirt can be

substituted. We recommend that the camp shirt or light blue shirt be worn every day for safety reasons. If a camper is not wearing a light blue shirt on off-site field trip days, they will not be permitted into the program at drop off. It is recommended that your child brings a hat and sunscreen for sun protection. Campers should have their bathing suit and a towel with them daily at camp.

SNEAKERS AND SOCKS MUST BE WORN DAILY. A CAMPER WHO IS NOT WEARING SNEAKERS WILL NOT BE PERMITTED INTO CAMP, IN THE EVENT THEIR SNEAKERS ARE NOT ON DURING THE CAMP DAY THEY WILL NOT BE PERMITTED TO PARTICIPATE IN CAMP ACTIVITIES. WATER SHOES ARE OK FOR THE POOL/SPRINKLER ONLY, NO SANDALS.

Lunch and Snacks

Children are responsible for bringing their own lunch, snack, and drink every day. We will not be providing lunch or snacks for the campers. Water to refill bottles will be readily svaliable for campers throughout the day. Please the aware that some campers may have an allergy to nuts. Please limit the amount of nut products your child brings to camp. In the event your child has brought a nut product to camp please let us know at the time of drop off. Campers will not be permitted into the program if they are missing their lunch or water bottle at the time of drop-off.

We have many campers with food allergies. To ensure safety we wash our hands before funch and immediately after. Campers with allergy items in their funch sit apart from campers who do not have allergy items in their lunch. Our staff is also trained to recognize the signs and symptoms of anaphylactic shock and how to use an epi-pen. The Town of West Seneca does not provide Epi-Pens.

Camper's lunch and water bottle should be labeled with their first and last name every single day.

We do not have a fridge and we suggest packing funches that are able to be unrefrigerated or packing funches in the insulated funch boxes with funch cold packs. All funch items should be labeled with the campers' first and last name.

It is the parent/guardians who drops the camper off responsibility to ensure the camper has a lunch.

In the event, it is discovered throughout the day that a camper does not have their lunch our staff will call his/her parent or guardian. In the event, a parent or guardian cannot be contacted or cannot arrange to bring their child lunch within 10 minutes of contact the fown of West Seneca will provide lunch. A \$10.00 fee will be due at the time of pick-up. If the fee is not paid by the next morning the Camper will not be permitted to attend camp until the fee is paid. If this happens three (3) or more times during the program the camper may be ejected from camp. The Town of West Seneca will not refund any fees for the current or future sessions.

be re-scheduled, an alternative activity will run, no refund will be issued. Hands-on activities by guests may not be allowed due to COVID-19.

Field Trips & On-Site Guests are subject to change without notice and without refund for any reason.

Field Trips & On-Site Guests that take place outdoors on days with inclement weather will not take place, the trip will not be rescheduled, and a refund will not be issued.

A decision to cancel an on-site trip or guests can be made at any time, if the on-site trip or guest is canceled a refund will not be issued.

Town of West Seneca staff is not permitted to transport any camper in their cars for any reason.

Grouping Requests

Due to COVID-19, we will not accept grouping requests. Due to COVID-19 campers will only be able to interact with members of their group, groups will not intermix (in previous years groups may participate in an activity together and/or spend pre- and post-camp together). Members of the same household will be grouped together regardless of age. Groups will be determined based on who is signed up for which weeks. We must make it a priority that campers stay with the same campers throughout the summer. If this changes we will notify you ASAP via the email address you use at the time of registration.

If we do end up accepting Grouping Requests:

- We believe making new friends is a rich component of the camp experience. We will make every
 effort to accommodate requests in compliance with our placement policies. There are multiple
 large group activities at camp so even friends who are not in the same group will see each other
 throughout the day.
- Grouping Requests will only be accepted at the time of Registration and/or by a deadline
 outlined in the notification email. Grouping requests can only be made for other campers.
 Grouping requests for group numbers will not be permitted. Grouping requests for staff
 members will not be permitted. Grouping requests made after the time of registration will not
 be accepted. Assignments for campers and groups are planned for all weeks before the program
 begins. Again, we will not accept grouping requests it after the time of registration or deadline.
- Requests are not required to be granted. Grouping is at the discretion of the West Seneca Youth
 Recreation Department.

Due to COVID-19, we will not be able to utilize our cooler system as we have in the past, lunches will be stored in each camper's locker room (hook) or backpack and out of the sun until lunchtime. We still suggest that campers pack lunches that can be unrefrigerated or pack lunches in the insulated lunch boxes with lunch cold pack. All lunch items must have the campers' name on them.

In the event, it is discovered throughout the day that your camper forgets their water bottle our staff will call his/her parent or guardian. In the event a parent or guardian cannot be contacted or cannot arrange to bring their child a water bottle within thirty minutes of contact West Seneal Youth & Recreation will provide a sealed disposable water bottle. A \$3.00 fee will be due at the time of pick-up. If the fee is not paid by the next marring the Camper will not be permitted to attend camp until the fee is paid. If this happens three (3) or more times during the program the camper may be ejected from camp. The Town of West Seneca will not refund any fees for the current or future sessions.

Money

We highly suggest that your child does not bring money to camp. The Town of West Seneca is not responsible for any camper's lost money. Staff members are not allowed to hold tamper's money.

Specific Needs

Day Camp will be filled with activities that encourage the camper to be active. If your child is not able to participate in any activity, please notify your child's counselor. We encourage you to notify us of any special needs or concerns that your may have.

In the event your child has a disability (mental, physical, etc), chronic illness, or a behavioral issue please notify us on their registration form. This will allow our Camp Director to properly plan and staff for the safety of this camper and all campers. In the event the parent does not inform the Town of West Seneca of this on the registration form when they register their camper – the child will not be permitted to stay at camp.

Field Trip & On-Site Guests Information

<u>Due to COVID-19 compers will not an on ony off-site field trins during the 2022 season.</u> However, we will have several on-site field trips and guest speakers. Please note that any camp activities including on-site guests/trips could be canceled at any time for any reason with no notice, the activity or guest may not

Grouping

Groups are determined by age. Group 1 consists of our youngest participants at age 6, and consecutively increases with the child's age. This is done to ensure that each child is participating in age-appropriate activities that are planned throughout the duration of the summer.

Medical Information

Camp staff is not allowed to dispense medication. If your child shows up to camp ill or becomes ill during camp hours, you will need to pick them up immediately or arrange to have them picked up. Campers must be picked up within 20 minutes of their parent/guardian being notified. Failure to do so could result in your camper being ejected from the program for the remainder of the season and no refund will be issued.

For the health and well-being of all, a child with a communicable/contagious illness within 24 hours of the camp date may NOT attend camp. Campers must have a doctor's note stating they can return to the program before they are allowed to return. Contagious illnesses include (but are not limited to) a cold, cough, sore throat, excessively runny nose, fever, childs, conjunctivitis (pink eye), lice, signs of general fatigue/discomionr, upset stomach, diarrhea, womiting, etc. Should a child exhibit any symptoms of a contagious illness, Recreation staff will call the child's contacts to have the child picked up from camp.

We ask that you call/email Recreation Supervisor Lauren J. Masset (<u>Imasset@twsmv.org</u> or 674-6086) if your child is diagnosed or has come in contact with any of these communicable illnesses. In the event of the presence of communicable illnesses, it will be shared with the camp group (without showing names) by a note from the Recreation Department.

For strep throat, pink eye, or any contagious illness being treated with antibiotics, the CDC recommends 24 hours on medication before returning to camp. You must also provide a doctor's note stating your child can return to camp.

Camp staff is not allowed to apply insect repellant or sunscreen to campers. You should do this before sending your child to camp. We suggest you teach your child how to apply these items to themselves before sending them to camp.

We are required by the Erie County Health Department to have the immunization and physical records for all Campers. If you do not submit the camper's immunization or physical records at the time of registration your registration will be canceled and no refund will be issued.

IF YOU SUBMITTED THESE RECORDS IN A PREVIOUS YEAR, YOU MUST STILL RE-SUBMIT THEM THIS

Allergies, Inhalers, Epi-pens, and Medicine

There will be children enrolled in our Day Camp that have asthma or other serious allergies. Out of respect for these children, we ask that you please do not send snacks or lunch for your child that may contain not products or other allergens. If you do send your child to camp with any products that contain nuts or other allergens, please notify camp staff at drop-off. Please see our lunch section for

To protect children with serious allergies our staff needs to be aware of any children who carry inhalers or epl-pens. It is important and required to mark this information on your registration forms and have your doctor's permission for your child to carry this medication.

Prior to the start of camp, you must turn in the medical authorization form (on our website) signed by both you and your child's doctor with a copy of the prescription of the medicine your child will be carrying attached. The medication that your child brings to camp must be in its original container showing the prescribed information on it. At the time of drop-off, please provide the medicine and a second copy of the doctor's prescription note to the camp staff. At this time, you will complete a medicine sign-in form. This policy is for both over-the-counter and prescription medicine. In the event your child is found to have any medicine of any kind with them at camp that does not follow the above policy (such as in their bag, on their person, etc) they may be ejected from the program and no refund will be issued. The department may also contact West Seneca Police or OCFS

THE TOWN OF WEST SENECA DAY CAMP STAFF CANNOT ADMINISTER MEDICINE TO ANY CAMPER AT ANY TIME FOR ANY REASON.

Remember, these policies are to protect your child, other campers, and staff. We trust that everyone will help ensure that these rules are carried out. The signed authorization must be completed before your child can attend camp.

Children at Risk

All childcare agencies are required by law to report suspected child abuse or maltreatment if they have reasonable cause to suspect it. Our staff is trained in recognizing abuse and maltreatment.

Sunscreen Utilization at Camps

Written Physician orders are not required for campers to carry and apply sunscreen at camp. The sunscreen must be approved by the FDA for over-the-counter use and must be accompanied by written permission of the parent or guardian that the camper may carry and apply sunscreen. Sunscreen must be labeled with the campers' first and last name. Sunscreen should be applied before sending your child to camp. Staff is not allowed to apply sunscreen to campers. We suggest teaching your camper how to apply sunscreen before they attend camp.

Emergency Procedure

Below are our procedures for emergencies that are approved by the New York State Department of

- 1. The Camp Program Director shall be in charge of the situation.
- 2. Administer First Aid
- 3. Call an ambulance for injuries including but not limited to: areas showing swelling combined with discoloration, deformity, loss of consciousness, any type of neck or back injury. Designate staff members to meet ambulance and direct crew to the scene
- 4. Other staff to secure area no child left unattended
- 5. Notify parents
- 6. Notify Director of Recreation
- 7. Upon conclusion, submit Town & State report. The report should include all events leading to injury of a child, name, and address of the child, name, and address of parent or guardian, staff involved, where treated and by whom, and recommendations to avoid future incidents

There will be fire and lost campers drills weekly. All flammable materials will be stored away from activity centers and kept under lock and key. Each area of the camp will have functioning smoke detectors and fire extinguishers.

Please note that the department may run drills during the camp day for fire, injury, missing camper(s), and other emergencies. Your camper could be part of these drills. If you prefer your camper not to be part of these drills please email Imasset@twsnv.org before the first program date.

Maltreatment can be such things as failing to provide proper medical care, excessive punishment, misuse of alcohol, drugs, etc

We will also report any threats of violence or harm a camper makes towards themselves or someone else to the proper authorities

The Town of West Seneca reserves the right to contact the West Seneca Police Department regarding any situation, at any time, for any reason. Parents may or may not be notified.

Weather Information

The Summer Day Camp takes place mostly outdoors. This means your child will be outside in the sun and heat for the majority of the day, it is required that your child bring a water bottle labeled with their name every day. Your child and their clothes will get dirty. Due to COVID-19 water fountains may not be available. However, water bottle fillers will be available. Due to COVID-19 campers will be outside as much as possible this includes days with high temperatures and light rain.

The temperature, storms, and other weather conditions are major factors for Camp. It is very important that you dress your child appropriately for days that are overcast or when rain is expected

When there is inclement weather at camp the activities will take place inside the Town Ice Rink,

When there is inclement weather that could affect an offsite or onsite field trip, the trip may be canceled. The Town of West Seneca reserves the right not to reschedule the trip and a refund will not be issued. For more information see the Field Trips section of this handbook.

Responding to Extreme Heat

Your camper is required to bring a water bottle labeled with his/her name to camp every day. Due to COVID-19 water fountains may not be available. However, water bottle fillers will be available

Sun and heat safety begins before any campers join us. We establish best practices during staff training by learning how the effects of the sun and heat exposure differ for children versus adults. Sports and activities are modified and often moved under the shade with extra water breaks. In extreme heat, programming would be entirely indoors treating a heat day the same way we would be in a lightning

You must also update your online account, if your emergency number changes it is important that we are notified immediately to ensure proper notification of parents in case of emergency. Town of West Seneca may eject a camper from the program and/or turn the camper over to the West Seneca Police Department, OCFS, or the proper authorities at any point if the parents/guardians do not report that their contact information has changed and/or we do not have a working phone number on file for the parent/guardian.

Contacting Your Child

Campers are not allowed to bring or use cell phones at camp.

Appropriate Behavior of Children at Camp

- Regarding actions and language towards oneself, counselors, and other campers
- Regarding responsibility for their clothing, snacks, backpacks, money, etc.
- Aggressive behavior is not appropriate and will not be tolerated. Respect for others, staff, and equipment
- Use of appropriate language and topics of conversation at all times
- No hitting, tripping, pushing, tackling, kicking, fighting, or wrestling Your child may not leave camp without permission from Camp staff and parents
- All children are expected to assist in picking up after their games/activities.
- Proper behavior on the bus

Discipline Procedures

Please prepare your child for the Summer Day Camp by explaining all the rules and regulations to your child and discussing any concerns that he/she may have. Please bring to our attention any problems that your child may be experiencing while at camp.

Campers must display acceptable behavior and must be accountable for their actions. Parents must be aware of the rules that their child is expected to abide by.

The first time a camper is disciplined he/she will be asked to sit out of the activity. If the problem continues the Camp Program Director will meet with the camper and their counselor to discuss and review the appropriate behavior.

Any significant or continual behavior problems will be brought to the attention of the parents in writing.

If a child receives three behavior notices (for one or a combination of reasons) during camp they will be ejected from the program. The Town of West Seneca reserves the right to immediately eject a camper without giving three notices for any behavioral issue.

If the behavior problem continues the child may be dismissed from the program without further warning. Campers who are dismissed will not be refunded for current or future session (ees.

Campers will be sent home and may be ejected from the program immediately if they attempt to destroy. The Town of West Seneca property or get into a physical altercation with another camper. Campers who attempt to destroy property or get into an altercation, parents must meet with the Camp Director before their child will be allowed back into camp. These actions could result in your child's immediate ejection from the camp program, for the entire length of the season, with no refund.

Any camper who intentionally injures or is a threat to another camper will be dismissed from the program for the current session and any future sessions. The West Seneca Police will also be notified.

Any child who intentionally destroys camp property may be dismissed from the program for the current session and any future sessions. Any vandalism charges will be charged to the camper involved and to his or her parent(s) or guardian(s). The West Seneca Police will also be notified.

Tie-Dye Day

If applicable to the year. Tie-Die day takes place on-site at the West Seneca Ice Rink. Campers are required to bring a white cloth item to tie-dye in a zip lock bag, labeled with their lists and last name. This could be a shirt, socks, pillowcase, etc. Campers will be allowed to tle-dye a maximum of one [1] item. If your camper does not bring an item, one will not be provided for him/her.

Tie-Dye Instructions

- Leave Tie-Oyed item in the bag you brought it home in for 24 HOURS.
- Once you are ready to wash your item, open the bag up in a sink, tub, outside, or somewhere
 you can easily clean and won't be ruined if some dye gets on it. ASK AN ADULT where you should
 fines lit.
- Take your item out of the bag, remove all the rubber bands, and unfold your tie-dyed item and
 take a look! Rinse the shirt with water, first cold, then warm, then hot. Rinse the item a couple of
 times at each temperature until the water runs almost clear.
- Wash your item before using it. Put it in a washing machine, WITH NOTHING ELSE, and wash the
 fabric, with soap, as you normally would.
- Once the fabric has been washed, it is ready to wear or use and can be washed and dried with your regular laundry.

Personal Belongings

Due to COVID-19 campers are not permitted to bring any items from home except the required daily items. Campers who are found to bring additional items from home could be ejected from the program.

The Town of West Seneca Recreation Department is not responsible for lost, stolen, or misplaced property. Please do not allow your child to bring any items that are of value to camp. The staff is not able to hold or keep track of any personal litems for any of the campers. Campers' first and last names should be listed on every item they bring to camp. Campers who are found to have personal items on them during the camp day will be instructed to place these items in their bag. This includes a backpack, jacket, sweatshirt, t-shirts, bathing suits, water shoes, towels, water bottles, lunch, changes of clothes, etc.

Please be sure your child has these Items dally:

- Lunc
- Snack

Any camper who bullies another camper, staff member, or other person(s) will be dismissed from the program for the current session and any future sessions. The West Seneca Police will also be notified.

Any camper who has non-approved medicine (non-prescription or prescription), lighters, tobacco products, e-cigarettes, illicit substances, drugs, alcohol, or weapons of any kind on them will be ejected from the program for the current session and any future sessions. The West Seneca Police will also be notified.

Campers who are suspended/dismissed/ejected for any reason will not be refunded for current or future session fees.

Campers who are suspended/dismissed/ejected for any reason from the program will not be eligible to enroll in the program the following year.

School Bus Rules for Off-Site Field Trips

Remind your child:

- . They must remain in their seat at all times on the bus
- They must wear their seat belt
- No objects or body parts are to be outside of the bus windows
- . Not to write on any part of the bus
- Not to litter on the bus
- To keep feet out of the aisles
- To listen carefully for roll calls
- Not to eat or drink on the bus

Trip Rules

Stop, Look & Listen

We ask that your camper does not bring any personal items from home except those required. All Items should be labeled with the campers' first and last name. No exceptions.

Please keep in mind that this is a Camp, and everything is open and accessible. Also, there are no separate classrooms or lockers in which to safely store a camper's personal item or money. The Town of West Seneca is not responsible for any personal items lost or stolen.

The Town of West Seneca will not be held liable for any missing items or money.

If your camper(s) arrive at camp without sneakers on their feet, a water bottle, or a lunch they will not be permitted into the program. No refund will be Issued.

If your camper(s) arrives at the camp without a bathing suit, water shoes, and a towel they will be required to sit out from all water activities.

Due to COVID-19 if your campers arrive at camp without a change of clothes, in a plastic bag, labeled with their first and last name, and their clothes are soiled with any type of bodily fluid throughout the day, they will be kept separate from the other campers in the camp infirmary until a change of clothes is provided and/or they are picked up. The change of clothes must arrive or the camper is picked up within 20 minutes of the parent/guardian being notified, failure to do so could result in the camper being ejected from the program for the remainder of the season, no refund will be issued.

COVID-19

Due to COVID-19, the Town of West Seneca reserves the right to not allow any camper into the program at drop off and/or send them home at any time (pick up is required within 20 minutes). The Town of West Seneca reserves the right to take your camper's temperature at any time and/or ask them the COVID-19 screening questions at any time. The program could be canceled or shut down for any length of time with no notice due to COVID-19.

Campers will be required to wear face coverings for a large majority of the day except when eating, during some water activities, and possibly during other activities at the Town of West Seneca discretion. Campers will not be permitted into the program without a face covering. Please discuss the

face-covering requirement with your camper. Furthermore, face coverings cannot be shared between persons.

COVID-19 Screening:

Parents/Guardians must pre-screen their campers for signs/symptoms of COVID-19 each day within one hour prior to dropping your camper off. Parents/Guardians must ensure that their camper can answer NO to each question below prior to sending their camper to camp each day. If the answer is YES to any question below, you must keep your camper home.

- a. Has your camper knowingly been in close or proximate contact in the past 10 days with anyone who has tested positive through a diagnostic test for COVID-19?
 Has your camper or anyone in the camper's household tested positive through a
- diagnostic test for COVID-19 or had inconclusive test results in the past 10 days? Does your camper or anyone in the camper's household have pending diagnostic test results for COVID-19?
- d. Has your camper experienced any symptoms of COVID-19, including, but not limited to, a temperature of greater than 100.0 F in the past 14 days? If your camper is not fever-free, without the assistance of medicine for 48 hours, your camper cannot attend
- Has your camper traveled internationally or for a period of 24 hours or more within another State (other than Connecticut, Massachusetts, New Jersey, Pennsylvania, or

There will be no refunds for non-attendance related to COVID-19. The requirement that Parents/Guardians must conduct a pre-screen will be strictly enforced. If we determine there has been a failure to abide by the pre-screen requirements, a camper and all other campers in the same household may be asked to leave the camp for the remainder of the 2022 camp season and may not be eligible to register for camp in 2023.

The Town of West Seneca reserves the right to pre-screen any camper at the time of drop off with the above questions, additional questions, symptom check, and/or temperature check.

Program Cancelled due to COVID-19.

The Town of West Seneca is subject to all government mandates related to COVID-19 and summer camp programs. The government mandates are frequently changing, and the Town of West Seneca is staying diligently abreast of all changes. It may be necessary to make changes to the camp program from time to time to comply with such mandates. The Yown will make any necessary adjustments to ensure it is fully compliant at all times. Keep in mind that to operate the camp program, the Town must have sufficient staffing levels. Those staffing levels may be affected by COVID-19 and may interfere with the Town's ability to operate the camp program. If the Town must cancel all or a portion of the camp

If a camper is sent home and/or not admitted into the program for a temperature over 99°, experiencing signs/symptoms of COVID (list can be found on the CDC website), positive screening answers, or otherwise based on concerns related to COVID signs/symptoms, they will not be permitted to return to the program until they can (a) provide a negative COVID-19 test; (b) provide a doctor's note with an alternative diagnosis (note must state the camper can return to camp and must also state what is causing the symptoms); or (c) does not attend the program for 10 days. - Groups will remain the same for the entire session, same campers, same staff. In previous years, staff sometimes varied during pre/post camp.
 - Each group will have their own equipment pack, we will avoid sharing, items used will be easy to sanitize. In the past, each group had their own packs, but items varied, and they were able to be
- Any items that cannot be sanitized between uses will not be used, this will limit our ability for crafts and board games, in previous years we had limited crafts and lots of board games.
- Campers will not be permitted to bring any non-required items from home. 2019 and prior years, campers were allowed to bring some items from home.
- Siblings could be grouped together. In previous years, if the age difference was wide, we did not Groupings will be kept as consistent as possible throughout the summer, same campers, same group them together.
 - Groups will have very limited interaction with other groups. They will be kept separate as much weeks, same staff.
 - Coolers will not be available for lunch storage. Campers must bring lunches that are as possible.
- The ECDOH/NYSDOH could change regulations at any time. If this is the case the Town will also change regulations at any time, with no notice. We will do our best to notify families, however, between the change and the notification that families are not aware of the change and are still notification will take place after the change has been made.
