Dear Ms. Hawthorne,

Per our previous conversation, the West Seneca Joint Veterans Committee passed a resolution transferring the ownership of the Korean War Monument (located in the Walkway of Freedom complex) from the Veterans Committee to the Town of West Seneca. The Veterans Committee deems it right and just that all war monuments honoring West Seneca veterans should be under the trusteeship of the Town of West Seneca.

The transfer of a war monument to the Town of West Seneca is not without precedent. The Vietnam War Monument was transferred from a committee that raised funds for the creation of Vietnam War Memorial to the Town of West Seneca.

Attached is the October 22, 2021 resolution from the West Seneca Joint Veterans Committee, as well as all of the paperwork associated with the purchase of the Korean War Monument from Stone Art Memorial Company, 914 Ridge Road, Lackawanna, New York.
